10. LEAVE OF ABSENCE.

- PERSONS TRANSFERRED TO THE INSTITUTION FOR (A) TREATMENT ARE ELIGIBLE FOR THE WORK RELEASE AND LEAVE OF AESENCE PROGRAMS PROVIDED FOR IN SECTIONS 700A THROUGH 700D-1 OF ARTICLE 27 OF THE CODE. THE FUNCTIONS OF THE WARDEN OR SUPERINTENDENT AND THE COMMISSIONER UNDER THOSE SECTIONS SHALL BE PERFORMED BY THE EOARD CF REVIEW WITH RESPECT TO PERSONS CONFINED IN THE INSTITUTION.
- IN ADDITION TO THESE PROGRAMS THE BOARD REVIEW MAY GRANT EXTENDED LEAVE TO A-DEFECTIVE-DELINQUENT AN ELIGIBLE PERSON FOR A PERIOD NOT TO EXCEED ONE YEAR IF THE BOARD OF REVIEW CONCLUDES THAT THE EXTENDED LEAVE (1) WILL NOT IMPOSE AN UNREASONABLE RISK ON SOCIETY AND (2) WILL ASSIST IN THE TREATMENT AND REHABILITATION OF THE DEFECTIVE DELINQUENT ELIGIBLE PERSON. THE EOARD OF REVIEW MAY ATTACH REASONABLE CONDITIONS TO THE EXTENDED LEAVE, AT ANY TIME MAKE REASONABLE AND APPROPRIATE MODIFICATIONS OF THESE CONDITIONS, AND REVOKE THE LEAVE IF IT FINIS THAT THE PERSON HAS VIOLATED A CONDITION OF THE LEAVE.

11. RELEASE FROM INSTITUTION.

- A DEFECTIVE DELINQUENT PERSON CONFINED AT THE INSTITUTION SHALL BE RELEASED UFON EXPIRATION OF HIS SENTENCE IN THE SAME MANNER AND SUBJECT TO THE SAME CONDITIONS AS IF HE WERE FEING RELEASED FROM A CORRECTIONAL FACILITY. THE DIRECTOR SHALL NOTIFY THE COMMISSIONER 30 DAYS PRIOR TO THE RELEASE.
- AT ANY TIME AFTER TRANSFER OF A PERSON TO THE INSTITUTION FOR TREATMENT AS A-DIFFCTIVE-DELINQUENT AN ELIGIBLE PERSON BUT PRIOR TO THE EXPIRATION OF THE PERSON'S SENTENCE, THE BOARD OF REVIEW, UPON REVIEW OF THE PERSON MAY TAKE THE FOLLOWING ACTION:
- IF THE BOARD OF REVIEW CONCLUDES THAT (1) THE PERSON IS NO LONGER A-DEFECTIVE DELINQUENT AN ELIGIBLE PERSON BUT SHOULD REMAIN CONFINED UNTIL RELEASED ON PAROLE IN ACCORDANCE WITH NORMAL PAROLE COMMISSION SIANDARDS OR EXPIRATION OF HIS SENTENCE OR THE INMATE REQUESTS A TRANSFER IN WRITING, THE DIRECTOR SHALL NOTIFY THE COMMISSIONER AND SEND HIM A CCFY OF THE EVALUATION TEAM'S REPORT. WITHIN 30 90 DAYS AFTER THAT NOTICE, THE PERSON SHALL BE DELIVERED TO THE AFFROPRIATE CORRECTIONAL FACILITY DESIGNATED BY THE COMMISSIONER. THIS TRANSFER SHALL NOT AFFECT ANY RIGHT TO PARCLE CONSIDERATION THAT THE PERSON MAY THEN HAVE.
- (2) IF THE BOARD OF REVIEW CONCLUDES WILL NOT IMPOSE AN UNREASONABLE RISK CN SOCIETY (1) (2) IT WILL ASSIST IN THE TREATMENT AND AND REHABILITATION OF THE DEFECTIVE -- DELINQUENT ELIGIBLE PERSON, IT SHALL GRANT A PAROLE FROM THE INSTITUTION FOR A PERIOD NOT EXCEEDING ONE YEAR. THE BOARD OF REVIEW MAY ATTACH REASONABLE CONDITIONS TO THE PAROLE, AT ANY TIME
