~~(A) (1) THE APPLICATION FOR A LICENSE TO CONDUCT A HARNESS HORSE RACE MEET SHALL BE FILED WITH THE COMMISSION ON OR BEFORE A DAY FIXED BY THE COMMISSION. THE APPLICATION SHALL SPECIFY THE DAYS ON WHICH HARNESS HORSE RACING IS DESIRED TO BE CONDUCTED, AND SHALL BE IN A FORM AND SUPPLY CERTAIN DATA AND INFORMATION, AS THE COMMISSION PRESCRIBES.~~

~~(2) THE ERECTION AND CONSTRUCTION OF THE TRACK, GRANDSTAND AND BUILDINGS OF ANY APPLICANT FOR A LICENSE TO CONDUCT HARNESS HORSE RACING UNDER THIS ARTICLE, IS SUBJECT TO THE INSPECTION OF THE COMMISSION, WHICH MAY ORDER AN ENGINEERING EXAMINATION AS THE COMMISSION DEEMS NECESSARY, AND MAY EMPLOY INSPECTORS AS THE COMMISSION CONSIDERS NECESSARY FOR THAT PURPOSE.~~

~~(B) THE COMMISSION MAY REJECT ANY APPLICATION FOR A LICENSE FOR ANY REASONABLE CAUSE AND THE ACTION OF THE COMMISSION SHALL BE FINAL.~~

~~(C) ON OR BEFORE JANUARY 15 OF EACH YEAR, THE COMMISSION SHALL AWARD ALL DATES FOR HARNESS RACING IN THIS STATE WITHIN THE CURRENT YEAR.~~

~~(B) IF ANY LICENSE IS SUSPENDED OR REVOKED BY THE COMMISSION, THE COMMISSION SHALL PUBLICLY STATE ITS REASONS FOR DOING SO AND ENTER THESE REASONS ON THE MINUTE BOOK OF THE COMMISSION.~~
