PAPERS, DOCUMENTS, OR OTHER PERIINENT DATA, IN ANY DISCIPLINARY MATTER OR PROCFEDING WHERE A VIOLATION OF THIS SUBTITLE IS ALLEGED.

- (E) THE BOARD MAY APPLY FOR FELIEF BY INJUNCTION, WITHOUT BOND, TO ENFORCE THIS SUBTITLE CR TO BESTRIAN ANY VIOLATION OF IT. IN THE FROCEEDINGS, IT IS NOT NECESSARY TO ALLEGE OR PROVE EITHER THAT AN ADEQUATE REMEDY AT LAW DOES NOT EXIST OR THAT SUBSTANTIAL CR INFEPARABLE DAMAGE WOULD NOT RESULT FROM THE CONTINUER VIOLATION. A MEMBER OF THE BOARD IS NOT PERSONALLY LIABLE UNDER THIS PROCEEDING.
- (F) THE EXERCISE OF ALL PCWEFS, AUTHORITY, DUTIES, AND FUNCTIONS VESTED IN THE BOARD BY THE PROVISIONS OF THIS SUBTITLE IS SUBJECT TO THE AUTHORITY OF THE SECRETARY OF LICENSING AND REGULATION AS SET FORTH IN THE LAWS OF THIS STATE.

- (A) ALL FEES CHARGED AND COLLECTED UNDER THIS SUBTITLE SHALL BE PAID TO THE BOARD AND DEFOSITED TO THE CREDIT OF THE STATE TREASURER. DISEURSEMENT OF THE AFPROPRIATIONS IN THE STATE BUDGET FOR SALARIES AND EXPENSES OF THE BOARD SHALL BE MADE IN ACCORDANCE WITH REGULATIONS OF THE STATE COMPTROLLER'S OFFICE.
- (B) THE BOARD SHALL KEEP A RECORD OF ITS PROCEEDINGS. THE RECORDS SHALL BE PRIMA FACIE EVIDENCE OF THE PROCEEDINGS OF THE BOARD SET FORTH IN THE RECORDS, AND A COPY OF THEM, CERTIFIED BY THE SECRETARY OF THE BOARD UNDER SEAL, IS ADMISSIBLE IN EVIDENCE WITH THE SAME FORCE AND EFFECT AS IF THE ORIGINAL WEEF PROLUCED.
- (C) AN ANNUAL ROSTER SHOWING THE NAMES AND MAILING ALDRESSES OF ALL PROFESSIONAL LAND SURVEYORS AND PROPERTY LINE SURVEYORS SHALL BE KEPT BY THE SECRETARY OF THE BOARD AND A COPY SHALL BE SENT FREE TO EACH REGISTRANT UPON RENEWAL. COPIES OF THIS ROSTER SHALL BE PLACED ON FILE WITH THE SECRETARY OF STATE AND FURNISHED TO THE PUBLIC AT A REASONABLE COST TO BE ESTABLISHED BY THE BOARD. EACH REGISTRANT SHALL ADVISE THE BOARD NOT LATER THAN JUNE 30 OF EACH YEAR, ON A FORM PROVIDED BY THE SECRETARY OF THE BOARD, OF HIS NAME, FLACE OF BUSINESS, MAILING ADDRESS, AND OTHER DATA CONSIDERED PERTINENT BY THE BOARD. THE NAMES OF THOSE REGISTRANTS WHO DO NOT PAY THE RENEWAL FEE BY JULY 1 OF EACH YEAR MAY NOT BE INCLUDED IN THE NEXT ISSUE OF THE PRINTED ROSTER.
- (D) ON OR BEFORE JUNE 30 OF EACH YEAR, THE BOARD SHALL SUBMIT TO THE SECRETARY OF LICENSING AND REGULATION A REPORT OF ITS TRANSACTIONS OF THE FRECEDING YEAR.
