OF LIKE OR DIFFERENT NAME:

- (6) ATTEMPT TO USE AN EXPIRED OF REVOKED OR NCNEXISTENT CERTIFICATE OF REGISTRATION:
- (7) PRACTICE OR OFFER TO PRACTICE WHEN NOT QUALIFIED;
- (8) FALSELY CLAIM THAT HE IS REGISTERED UNDER THIS SUBTITLE: OR
- (9) VIOLATE ANY CTHEF PROVISION OF THIS SUBTITLE.
- (B) ANY PERSON WHO VIOLATES ANY FROVISION OF THIS SECTION IS GUILTY OF A MISDEMEANCF AND ON CONVICTION IS SUBJECT TO A FINE OF NOT LESS THAN \$100 AND NOT MORE THAN \$500 OR IMPRISONMENT FOR NOT MORE THAN SIX MONTHS OR EOTH.
- (C) ALL DULY CONSTITUTED OFFICERS OF THIS STATE AND ALL OF ITS POLITICAL SUBDIVISIONS SHALL ENFORCE THE FROVISIONS OF THIS SUBTITLE AND SHALL PROSECUTE ANY PERSONS VIOLATING SAME.
- (D) THE ATTORNEY GENERAL OF MARYLAND OR HIS ASSISTANT SHALL ACT AS LEGAL ADVISER TO THE ECARD AND RENDER THE LEGAL ASSISTANCE NECESSARY IN CARRYING OUT THE FROVISIONS OF THIS SUBTITLE.

## THIS SUBTITLE DOES NOT PREVENT OF AFFECT:

- (1) THE PRACTICE OF ANY OTHER LEGALLY RECOGNIZED PROFESSION OR TRADE;
- (2) THE WORK OF AN EMPLOYEE OR SUBCRDINATE OF A PERSON HOLDING A CERTIFICATE OF REGISTRATION UNDER THIS SUBTITLE, OR OF AN EMPLOYEE OF A FERSON PRACTICING LAWFULLY UNDER THIS SECTION, IF THE WORK IS CONE UNDER THE DIRECT RESPONSIBILITY AND SUPERVISION OF A PERSON HOLDING A CERTIFICATE OF REGISTRATION UNDER THIS SUBTITLE OF A PERSON PRACTICING LAWFULLY UNDER THIS SECTION; OR
- (3) THE PRACTICE OF OFFICERS AND EMPLOYEES OF THE GOVERNMENT OF THE UNITED STATES WHILE ENGAGED WITHIN THIS STATE IN THE PRACTICE OF THE PROFESSION OF LAND SURVEYING FOR THE GOVERNMENT.
- SECTION 6. AND BE IT FURTHER ENACTED, That any person who is registered by the State Board of Registration for Professional Engineers and Professional Land Surveyors as of July 1, 1977 as a Professional Land Surveyor, land Surveyor-in-training, or Property Line Surveyor shall be deemed to be registered by the State Board of Registration for Professional Land Surveyors.
