SUBFRANCHISOR UNTIL THESE OBLIGATIONS HAVE BEEN SATISFIED. AT THE OPTION OF THE FRANCHISOR, HE MAY FURNISH AN ADEQUATE SURETY BOND AS PROVIDED BY RULE OF THE COMMISSIONER. THE AGGREGATE LIABILITY OF THE SURETY MAY NOT EXCEED THE PENAL SUM OF THIS BOND.

REGISTRATION THE APPLICATION FOR SHALL BE ACCOMPANIED BY A PROPOSED OFFERING FROSPECTUS. WHICH SHALL CONTAIN THE MATERIAL INFORMATION SET FORTH IN THE APPLICATION FOR REGISTRATION, AS SPECIFIED BY RULE OF THE COMMISSIONER, AND ADDITIONAL DISCLOSURES AS HE MAY REQUIRE. THE APPLICATION FOR BEGISTRATION SHALL BE ACCOMPANIED BY A -- PROPOSED -- OFFERING -- FROSPECTUS, -- WHICH SHALL CONTAIN THE MATERIAL INFORMATION SET-FORTH-IN-THE APPLICATION-FOR-RECISTRATION-AS-SPECIFIED-BY-RULE-OF-THE COMMISSIONER THE COMMISSIONER MAY ACCEPT, IN LIEU OF THE REGISTRATION APPLICATION OR OFFERNG PROSPECTUS SET FORTH IN THIS SUBTITLE, A REGISTRATICN APPLICATION OR OFFERING PROSPECTUS REQUIRED BY A FEDERAL GOVERNMENT AGENCY, THE GOVERNMENT AGENCY OF ANOTHER STATE, OR A REGISTRATION APPLICATION AND OFFERING PROSPECTUS APPROVED AN ASSOCIATION OF THE ADMINISTRATORS OF FRANCHISE LAWS WHICH HE DETERMINES ENCOMPASSES DISCLOSURE REQUIREMENTS SIMILAR TO THOSE CONTAINED IN THIS SUBTITLE. THE PROSPECTUS SHALL RECITE IN BOLD TYPE OF NCT LESS THAN 10-POINT TYPE THAT REGISTRATION DCES NOT CONSTITUTE APPROVAL, RECOMMENDATION OR ENDORSEMENT BY CCMMISSIONER.

THE COMMISSIONER MAY ISSUE SUMMARILY A STOP ORDER DENYING THE EFFECTIVENESS OF OR SUSFENDING OR REVOKING EFFECTIVENESS OF ANY REGISTRATION IF HE FINDS:

- (1) THERE HAS BEEN A FAILURE TO COMPLY WITH ANY OF THE PROVISIONS OF THIS LAW OR THE RULES AND REGULATIONS OF THE COMMISSIONER;
- (2) THE OFFER OR SALE OF THE FRANCHISE WOULD CONSTITUTE MISREPRESENTATION TO, OR LECEIT OR FRAUD OF THE PURCHASERS;
- (3) ANY PERSON IDENTIFIED IN THE APPLICATION HAS BEEN CONVICTED OF AN OFFENSE UNDER SUBSECTION (5) OF SECTION 327, OR IS SUBJECT TO AN ORDER, OR HAS HAD A CIVIL JUDGMENT ENTERED AGAINST HIM AS DESCRIBED IN SUBSECTION (5) OF SECTION 327, AND THE INVOLVEMENT OF THIS PERSON IN THE SALE OR MANAGEMENT OF THE FRANCHISE CREATES AN UNREASONABLE RISK TO PROSPECTIVE FRANCHISES.

IF A STOP ORDER IS NOT IN EFFECT UNDER THIS SUBTITLE, REGISTRATION OF THE OFFER OF FRANCHISES AUTOMATICALLY BECOMES EFFECTIVE AT 12 C'CLOCK NOON OF THE
