AN AMENDMENT TO AN APPLICATION FILED AFTER THE EFFECTIVE DATE OF THE REGISTRATION OF THE SALE OF FRANCHISES, IF THE AMENDMENT IS APPROVED BY THE COMMISSIONER, SHALL BECOME EFFECTIVE ON THE DATE THE COMMISSIONER MAY DETERMINE, HAVING DUE REGARD FOR THE PUBLIC INTEREST AND THE PROTECTION OF FRANCHISEES.
