- (II) "SCHOOL" MEANS AN APPROVED PRIVATE FOSTSECONDARY EDUCATIONAL INSTITUTION LOCATED OUTSIDE OF THE STATE OF MARYLAND WHICH CHARGES TUITION OR FEES FOR ATTENDANCE OR INSTRUCTION TO STUDENTS WITHIN THE STATE OF MARYLAND, WHICH OFFERS A PROGRAM OF TRADE OR TECHNICAL EDUCATION OR BOTH, OR WHICH GIVES PREEMPLOYMENT OR SUPPLEMENTARY TRAINING CR BOTH, IN THE FIELDS OF TRADE OR INDUSTRY: BUT THIS TERM SHALL NOT INCLUDE ANY POSTSECONDARY INSTITUTION SUBJECT TC THE AUTHORITY OF THE STATE BOARD FOR HIGHER EDUCATION UNDER SECTION 32A OF THIS ARTICLE.
- [2] EVERY SOLICITES FOR ANY PRIVATE FOSTS ECONDARY SCHOOL DEFINED IN SUBPARAGRAPH (II) ABOVE SHALL APPLY TO THE STATE BOARD FCB HIGHER ECUCATION FOR AN ANNUAL PERMIT ON JULY 1 OF EACH YEAR. THE APPLICATION SHALL BE MADE ON FORMS SUPPLIED BY THE BOARD SHALL EVERY SOLICITOR FOR ANY CONTAIN SUCH INFORMATION AS THE EOARD DEEMS REASONABLE AND NECESSARY. TOGETHER WITH THE APPLICATION THE SOLICITOR SHALL SUBMIT FOR APPROVAL A COPY OF EACH TYPE OF CONTRACT OFFERED BY THE SCLICITOR TO PROSPECTIVE STUDENTS, TOGETHER WITH SUCH ADVERTISING MATERIALS AND OTHER REPRESENTATIONS AS ARE MADE BY THE SCHOOL TO ITS STUDENTS OR FROSPECTIVE STUDENTS.
- AFTER THE BOARD AFFFCVES THE APPLICATION AND UPON PAYMENT OF A FEE OF \$5, IT SHALL ISSUE TO THE SOLICITOR A PERMIT CARD PERMITTING THE SOLICITATION OF STUDENTS WITHIN THE STATE OF MARYLAND. THE PERMIT SHALL BE ISSUED ONLY ON AN ANNUAL BASIS, EXPIRING ON JUNE 30 OF EACH YEAR, AND IT MUST BE RENEWED ANNUALLY TO ENTITLE THE SOLICITOR TO ENGAGE IN HIS BUSINESS.
- (4) FOR A VIOLATION OF THE CONTRACT WITH THE STUDENT OR FOR OTHER GOOD CAUSE, THE BCARD MAY BEVOKE THE PERMIT ISSUED TO ANY SOLICITOR AFTER DUE NCTICE OF THE REVOCATION TO THE SOLICITOR AND AN CEPCRIUNITY TO BE HEARD ON THE REVOCATION.
- SECTION 4 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1977.
