CF PROBATION SHALL BE TRANSFERRED TO THE STATE DIVISION OF PAROLE AND PROBATION, AND THE DIVISION, ON AND AFTER THE EFFECTIVE DATE OF THIS ACT, SHALL ASSUME ALL OF THE DUTIES AND FUNCTIONS PREVIOUSLY ASSIGNED TO THE EMPLOYEES OF BALTIMORE COUNTY DESIGNATED UNDER THIS SUBSECTION, INCLUDING THE DISPOSITION OF MATTERS PENDING ON THAT DATE.

- (B) THOSE—EMPLOYIES—WHG—AFE—TRANSFERRED—SHALL
 BECOME—CLASSIFIED—EMPLOYEES—OF—THE—STATE—SUBJECT—TO—THE
 PROVISIONS—OF—THE—STATE—MERIT—SYSTEM—LAW—UNDER—THIS

- (B) ANY EMPLOYEE TRANSFERRED TO THE STATE MERIT SYSTEM PURSUANT TO THIS SECTION SHALL EE APPOINTED WITHOUT FURTHER EXAMINATION OR CUALIFICATION. EACH EMPLOYEE SHALL BE PLACED IN THAT CLASSIFICATION WHICH IS COMPARABLE TO, OR MOST CLOSELY COMPARES WITH, THE EMPLOYEE'S FORMER POSITION IN DUTIES AND RESPONSIBILITIES.

EMPLOYEES SO TRANSFERRED PURSUANT TO THIS SECTION MAY NOT SUFFER A DIMINUTION OF SALARY OR WAGES, ACCRUED PAID LEAVE WHETHER EARNED OR GRANTED, OR SENIORITY RIGHTS. ANY INCREASE IN SALARY OR WAGES GRANTED SUBSEQUENT TO JULY 1, 1976, MAY BE RETAINED UPON APPOINTMENT TO THE CLASSIFIED SERVICE CNLY IF APPROVED BY THE SECRETARY OF PERSONNEL. THE SECRETARY OF PERSONNEL SHALL CONSIDER THE MONETARY VAIUE OF ANY AND ALL OTHER BENEFITS, ENTITLEMENTS, SERVICES OF PERSOGATIVES AND, AT HIS DISCRETION AND IN CONSIDERATION OF THE FEST INTERESTS OF THE CLASSIFIED SERVICE MAY TAKE SUCH VALUES OR ANY PORTION THEREOF INTO CONSIDERATION WHEN ESTABLISHING THE RATE OF SALARY UPON APPOINTMENT. ONCE THE RATE OF SALARY HAS BEEN ESTABLISHED UPON APPOINTMENT, THE EMPLOYEE SHALL EF ENTITED TO THE SAME BENEFITS PROVIDED TO CLASSIFIED EMPLOYEES ESTABLISHED BY ARTICLE 644 OF THE CODE.

- (C) THOSE EMPLOYEES WHO AFE TRANSFERRED SHALL BECOME MEMBERS OF THE STATE EMPLOYEES FENSION FETTREMENT SYSTEM UNDER ARTICLE 73B OF THIS CODE, AND SHALL TRANSFER ALL CONTRIBUTIONS AS PROVIDED IN SECTION 32A OF ARTICLE 73B.
- (D) BALTIMORE COUNTY, MARYLAND, SHALL FURNISH THE DIVISION OF PAROLE AND PROBATION WITH SUITABLE SPACE, EQUIPMENT AND PACILITIES IN ORDER THAT THE DIVISION MAY DISCHARGE ITS RESPONSIBILITIES IN THE COUNTY.
