Article 2B - Alcoholic Beverages Section 28 (k) Annotated Code of Maryland (1976 Replacement Volume and 1976 Supplement)

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That new Section 28(k) be and it is hereby added to Article 2B — Alcoholic Beverages, of the Annotated Code of Maryland (1976 Feplacement Volume and 1976 Supplement) to read as follows:

Article 2B - Alcoholic Beverages

28.

- (K) IN-ANNE-ARUNDEL-CCUNTY,-THE-ECARD--OF--LICENSE COMMISSIONERS-MAY-APPROVE-THE-ISSUANCE-OF-A-BHT-LIGENSE, THIS-LICENSE PERMITS THE CONSUMPTION, CN THE PREMISES, FOR-TASTING-OR-SAMPLING-PURPOSES-ONIY,-GF-LIGHT-WINEV THE-LIGENSEE-MAY-NOT-SERVE-MORE-THAN-CHE-CUNCE-FROM--EACH GIVEN-BRAND-TO-ANY-ONE-PERSON---THE-COST-FOR-THIS-LICENSE IF-\$750-EACH-YEAR-
- (1) IN ANNE ARUNDEL CCUNTY, THE BOARD OF LICENSE COMMISSIONERS MAY APPROVE THE ISSUANCE OF A WT LICENSE. THE LICENSE IS ISSUED ONLY TO HOLDERS OF AN A (BWL) OR AN A (BW) LICENSE. THE LICENSE PERMITS THE CONSUMPTION FOR TASTING CR SAMPLING FURFOSES ONLY, ON PREMISES, OF LIGHT WINE. THE LICENSFE MAY NOT SERVE MORE THAN ONE OUNCE FROM EACH GIVEN ERAND TO ANY ONE PERSON. THE COST OF THE LICENSE FCR HCLDEFS OF AN- A (BWL) LICENSE WILL BE \$150 EACH YEAR IN ADDITION TO THE COST OF THE A (BWL) LICENSE. THE COST OF THE LICENSE FCB HOLDERS OF AN-A (BW) LICENSE WILL BE \$50 EACH YEAR IN ADDITION TO THE COST OF THE A-(BW) LICENSE.
- CITY COUNCIL MAY APPROVE THE ISSUANCE OF A WT LICENSE. THE COST OF THE LICENSE IS SET BY THE MAYOR AND CITY COUNCIL.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1977.
