picnic areas as used in this subsection, "community association" means any incorporated association whose membership is limited to voluntary subscriptions by residents of the community or development and which has no power either by law, convenant, or any other means to assess fees against residents or property owners based on property values.]

- In Harford County, the County Council
  may permit a tax credit, for Harford County taxes only,
  for real property which is owned by the Children's Fresh
  Air Society of Maryland, Inc., to the extent the acreage
  cn credit exceeds the credit allowed in Section 9(e) of
  Article 81 of the Code.]
- (J-1) IN HARFORD COUNTY, (1) FROM CCUNTY TAXATION ONLY, THE COUNTY COUNCIL MAY ALLOW TAX CREDITS FOR REAL PROPERTY OWNED BY COMMUNITY ASSOCIATIONS AND USED FOR PUBLIC PARKS, PLAYGROUNDS, OR FICHIC ARFAS. AS USED IN THIS PARAGRAPH ONLY, "CCMMUNITY ASSOCIATION" MEANS ANY INCORPORATED ASSOCIATION WHOSE MEMBERSHIP IS LIMITED TO VOLUNTARY SUBSCRIPTIONS BY RESIDENTS OF THE COMMUNITY OR DEVELOPMENT AND WHICH HAS NO FOWER FITHER BY LAW, COVENANT, OR ANY OTHER MEANS TO ASSESS FRES AGAINST RESIDENTS OR PROPERTY CWNERS BASED ON PROPERTY VALUES; (2) FROM COUNTY TAXATION ONLY, THE COUNTY COUNCIL MAY ALLOW A TAX CREDIT FOR REAL PROFFERTY WHICH IS OWNED BY THE CHILDREN'S FRESH AIR SOCIETY OF MARYLAND, INC., BUT ONLY FOR ACREAGE IN EXCESS OF THE EXEMPTION ALLOWED TO THE SOCIETY UNDER SECTION 9 (2) OF THIS ARTICLE; AND (3) FROM COUNTY TAXATION ONLY, THE COUNTY COUNCIL MAY ALLOW A TAX CREDIT FOR REAL PROFFERTY COUNCIL MAY ALLOW A TAXATION ONLY, THE COUNTY COUNCIL MAY ALLOW A TAXATION ONLY, THE COUNTY COUNCIL MAY ALLOW A TAX CREDIT FOR REAL PROFERTY CWNEI BY THE NORTH HARFORD GAME AND FISH ASSOCIATION, INC., LOCATED ON WHEELER SCHOOL ROAD, AND WHICH IS USED SCIETY FOR THE PURPOSES OF THE ASSOCIATION.
- Council may, by law, provide for tax credits against the amount of county taxes with respect to real or tangible personal property owned by community associations and used for community, civic, educational, library or park purposes. These credits may not be granted for any swimming pocls, tennis courts or similar recreational facilities.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1977.
