BUT DOES NOT INCLUDE (1)

PUBLIC WORKS, EXCEPT WHEN MERTING AS THE BOARD OF PUBLIC

BORKS AT AN OFFICIAL AND FORMAL METING, (2) THE

GOVERNOR'S EXECUTIVE COUNCIL OR ITS COUNCIL OR ITS

GOVERNMENT, OR ANY COMMITTEE OF THE COUNCIL OR OF ITS

GOUTERPART, OR (3) ENTITIES GREATED SCIELY TO MAKE

NOMINATIONS OR RECOMMENDATIONS OF PERSONS FOR ALPOINTMENT

BY A PUBLIC BODY OR PUBLIC OFFICIAL

- (1) (H) "QUASI-JUDICIAL FUNCTION" HEANS THE DETERMINATION OF A CONTESTED CASE IC WHICH THE FROVISIONS OF THE ADMINISTRATIVE PROCEDURE ACT OR CHAPTER 1100, SUBTITLE B, OF THE MARYLAND RULES ARE APPLICABLE. THE AFPROVAL OF RATES BY THE PUBLIC SERVICE COMMISSION OR BY THE HEALTH SERVICES COST REVIEW COMMISSION IS A COUASI JUDICIAL PUNCTION FOR PURPOSES OF THIS SUBTITLE.
 - (J) "QUASI-LEGISLATIVE FUNCTION" MEANS
- (1) THE ADOPTION, AMENDMENT, <u>DISAFFROVAL</u> OR REPEAL OF A RULE, REGULATION, OR FYLAW HAVING THE FORCE OF LAW BY A PUBLIC BODY; AND, OR THE PECCESS OF LOING SO;
- (2) THE APPROVAL, DISAFFROVAL, CF AMENDMENT OF A CONTRACT OR A BUDGET BY A PUBLIC BODY, OR THE PROCESS OF DOING SO.
- (K) (J) "QUORUM" MEANS A SIMPLE MAJORITY OF THE MEMBERS OF A PUBLIC BODY, UNLESS A DIFFERENT NUMBER IS REQUIRED BY LAW, RULE, OR REGULATION.

9. APPLICABILITY

THIS SUBTITLE SHALL APPLY TO A PUBLIC BOLY WHEN IT IS EXERCISING LEGISLATIVE, QUASI-LEGISLATIVE CF ADVISORY PUNCTIONS. THIS SUBTITLE SHALL NOT APPLY TO A PUBLIC BODY WHEN EXERCISING EXECUTIVE, JUDICIAL OR QUASI-JUDICIAL PUNCTIONS; THE GOVERNOR'S EXECUTIVE COUNCIL OR ITS COUNTERPART IN LOCAL GOVERNMENT, OR ANY COMMITTEE OF THE COUNCIL OR ITS COUNTERPART; OR THE BOARD OF PUBLIC WORKS, EXCEPT WHEN MEETING AT AN OFFICIAL AND FORMAL MEETING.

8 10. OPEN MEETINGS

- (A) THE SUBJECT TO THE PROVISIONS OF SECTION 9,
 THE MEETINGS OF EVERY PUBLIC BODY SHALL BE OPEN TO THE
 PUBLIC WHEN THE PUBLIC ECRY IS EXEFCISING AN ADVISORY,
 EXECUTIVE, LEGISLATIVE, QUASI-LEGISLATIVE, OR
 QUASI-JUDICIAL FUNCTION UNLESS CLOSED IN ACCORDANCE WITH
 SECTION 9 11.
- (B) MEMBERS OF THE GENERAL PUELIC HAVE THE RIGHT TO ATTEND THE OPEN MEETINGS OF PUELIC FODIES. A PUBLIC BODY MAY REMOVE OR CAUSE THE REMOVAL OF ANY PERSON OR PERSONS FROM AN OPEN MEETING UPON A DETERMINATION BY THE PRESIDING OFFICER OF THE PUBLIC BODY THAT THE PERSON'S BEHAVIOR IS DISRUPTIVE TO THE MEETING.
