## FOR THE PURPOSES OF THIS SUBTITLE:

- THE TERM "EMPLOYER" MEANS THE STATE OF MARYLAND AND ANY MUNICIPAL CORPORATION AS DEFINED IN SECTION 21 OF THIS ARTICLE. OR-ANY-POLITICAL-SUBDIVISION, OR-ANY-AGENCY-OR-INSTRUMENTALITY-ACTING-DIRECTLY-AS-AN ZMFLOYER-OR-INDIRECTLY-IN-THE-INTEREST-CF-AN-EMFLOYER,-IN RELATION-TO-A-PLAN: AND-INCLUDES-A-GROUP-GE-ASSOCIATION OF-STATE-OR-LOCAL-EMPLOYERS-ACTING-FOR-A-STATE--CR--LOCAL EMPLOYER-IN-SUCH-CAPACITY.
- THE TERM "EMPLOYEE" MEANS ANY INDIVIDUAL (2) EMPLOYED BY AN EMPLOYER.
- (3) THE TERM "PARTICIFANT" MEANS ANY EMPLOYEE OR FORMER EMPLOYEEE OR—AN—EMPLOYEER, OR—ANY MEMBER OR FERMER MEMBER OF AN EMPLOYEE ORGANIZATION, WHO IS OR MAY BECOME ELIGIBLE TO RECEIVE A BENEFIT OF ANY TYPE FROM A PLAN WHICH-COVERS-EMPLOYEES-OF-THE-EMPLOYER OR-MEMBERS-OF-AN-ORGANIZATION, OR WHOSE BENEFICIARIES MAY BE ELIGIBLE TO RECEIVE ANY OF THESE EFNEFITS.
- (4) THE TERM "PERSON" MEANS THE STATE OF MARYLAND OR ANY POLITICAL SUBDIVISION OR ANY AGENCY OR INSTRUMENTALITY, AN INDIVIDUAL, PARTNERSHIP, JOINT VENTURE, CORPORATION, MUTUAL COMPANY, JCINT-STOCK COMPANY, TRUST, ESTATE, UNINCCRPCEATED ORGANIZATION, ASSOCIATION, OR EMPLOYEE ORGANIZATION.
