- SHALL BE OWNER-OPERATORS OF COMMERCIAL FARMS WHO EARN 50 PERCENT OR MORE OF THEIR INCOME FROM FARMING.
- (B) IN EACH AGRICULTURAL FRESERVATION ADVISORY BOARD, ORIGINAL MEMBERS SHALL BE AFPOINTED FOR THE FOLLOWING TERMS:
 - (1) ONE FOR A TERM OF THREE YEARS;
 - (2) TWO FOR TERMS OF FCUR YEARS; AND
 - (3) TWO FOR TERMS OF FIVE YEARS.
- THEREAFTER, TERMS CF OFFICE SHALL BE FIVE YEARS. NO MEMBER SHALL SERVE FOR MCRE THAN TWO CONSECUTIVE FULL TERMS. APPOINTMENT TO FILL A VACANCY SHALL BE FOR THE REMAINDER OF THE UNEXPIRED TERM.
- (C) <u>FUTIES OF EACH AGRICULTURAL FRESERVATION</u>
 ADVISORY BOARD SHALL BE:
- (1) TO ADVISE THE COUNTY GOVERNING BODY WITH RESPECT TO THE ESTABLISHMENT OF AGRICULTURAL DISTRICTS AND THE APPROVAL OF PURCHASES OF FASEMENTS BY THE FOUNDATION WITHIN THE COUNTY:
- REVIEWING THE STATUS OF AGRICULTURAL DISTRICTS AND LAND UNDER EASEMENT:
- (3) TO ADVISE THE FCUNDATION CONCERNING COUNTY PRIORITIES FOR AGRICULTURAL EFFSERVATION;
- 44) TO PROMCTE PRESERVATION OF AGRICULTURE WITHIN THE COUNTY BY OFFERING INFORMATION AND ASSISTANCE TO FARMERS WITH RESPECT TO ESTABLISHMENT OF DISTRICTS AND PURCHASE OF FASEMENTS; AND
- 45) TO PERFORM ANY OTHER DUTIES AS ASSIGNED BY THE COUNTY GOVERNING BODY.

- [The foundation shall receive the funds provided in the state budget.]
- (A) THE MARYLAND AGRICULTURAL LAND PRESERVATION FUND IS CREATED AND CONTINUED FOR THE FURPCSES SPECIFIED IN THIS SUBJITLE.
