- (f) (1) [Benefits] SUBJECT TO THIS SUBSECTION, BENEFITS based on service in employment defined in § 20(g) (7) (iii) [shall be] ARE payable in the same amount, on the same terms, and subject to the same conditions as compensation payable on the basis of other service subject to this article[; except that].
- (2) AN INDIVIDUAL MAY NOT BE FAID benefits based on service PERFORMED BEFORE JANUARY 1, 1978 in instructional, research, or principal administrative capacity in an institution of higher education [(as defined in § 20 (g) (7) (iv)) shall not be paid to an individual] for any week of unemployment [which] THAT begins during the period between two successive academic years, or during a similar period between two regular terms, whether or not successive, or during a period of paid sabbatical leave FOR WHICH [provided for in] the individual's contract PROVIDES, if the individual has a contract or contracts to perform ANY OF THOSE services [in any such capacity] for [an] ANY institution [or institutions] of higher education for both [such academic] years or [both such] terms.
- (3) AN INDIVIDUAL MAY NOT BE PAIL BENEFITS ON SERVICE PERFORMED AFTER DECEMBER 31, 1977 IN AN INSTRUCTIONAL, RESEARCH, OR PRINCIPAL ADMINISTRATIVE CAPACITY FOR AN EDUCATIONAL INSTITUTION FOR ANY WEEK OF UNEMPLOYMENT THAT BEGINS DURING A PERIOD OF PATD THE INDIVIDUAL'S CONTRACT SAEBATICAL LEAVE FOR WHICH PROVIDES OR DURING THE PERIOD PETWEEN TWO SUCCESSIVE ACADEMIC YEARS OR A SIMILIAR PERICD BETWEEN TWO REGULAR BUT NOT SUCCESSIVE TERMS, IF THE INCIVIOUAL PERFORMS SERVICE IN THE FIRST YEAR OR TERM AND THERE IS A CONTRACT REASONABLE ASSURANCE THAT THE INDIVIDUAL WILL PERFORM SERVICES IN SUCH CAPACITY FOR AN EDUCATIONAL INSTITUTION IN THE SECOND YEAR OR TERM.
- (4) AN INDIVIDUAL MAY NOT BE PAID BENEFITS EASED ON SERVICE PERFORMED AFTER DECEMBER 31, 1977 IN ANY CAPACITY OTHER THAN INSTRUCTIONAL, RESEARCH, OR PRINCIPAL ADMINISTRATIVE FOR ANY EDUCATIONAL INSTITUTION FOR ANY WEEK THAT BEGINS DURING A PERIOD BETWEEN TWO SUCCESSIVE ACADEMIC YEARS OR TERMS, IF THE INDIVIDUAL PERFORMS THE SERVICE IN THE FIRST YEAR OR TERM AND THERE IS A REASONABLE ASSURANCE THAT THE INDIVIDUAL WILL FERFORM THE SERVICE IN THE SECOND YEAR OR TERM.
- (5) IN THIS SUBSECTION, THE TERM "INSTITUTION OF HIGHER EDUCATION" HAS THE MEANING STATED IN § 20(5) OF THIS ARTICLE.
- (G) AN INDIVIDUAL MAY NOT BE PAID BENEFITS BASED ON SERVICE THAT SUBSTANTIALLY CONSISTS OF PARTICIPATING IN SPORTS OR ATHLETIC EVENTS, OR TRAINING OR PREPARING TO PARTICIPATE, FOR ANY WEEK THAT BEGINS DURING A PERIOD BETWEEN TWO SUCCESSIVE SPORT SEASONS, OR OTHER SIMILAR
