- (B) A COUNTY, MUNICIPALITY, CF OTHER POLITICAL SUBDIVISION OF THIS STATE MAY NOT ADOPT CRDINANCES OR RESOLUTIONS IDENTICAL OF SUPPLEMENTAL TO THIS SECTION, AND ANY EXISTING CRDINANCE, FESOLUTION, OR OTHER LEGISLATION INCONSISTENT WITH THIS SECTION IS REPEALED.

ANY PERSON WHO VICIATES THE PROVISIONS OF THIS SUBHEADING IS GUILTY OF A MISDEMEANCE AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$100 OR IMPRISONMENT NOT EXCEEDING 90 DAYS, OR BOTH.

- (A) THE COUNTIES ENUMERATED IN THIS SECTION MAY ADOPT ORDINANCES OR RESOLUTIONS SUPPLEMENTING THIS SUBHEADING. THIS INCLUDES THE AUTHORITY TO REGULATE POSSESSION OR CONSUMPTION OF ANY ALCCHOLIC EFFERAGE ON ANY PUBLIC PROPERTY, PROPERTY USED BY THE PUBLIC IN GENERAL, OR ON ANY HIGHWAY.
