GRCUP OF PERSONS.

- (5) "DOCKET" MEANS A RECORD MAINTAINED BY THE SECRETARY OF STATE IN WHICH ARE REGISTERED THE NAME, RESIDENCE AND OCCUPATION OF THE PERSON EMPICYED, TOGETHER WITH THE NAME AND BUSINESS ADDRESS OF THE EMPLOYER, THE DATE OF EMPLOYMENT OR AGREEMENT THEREOF, THE LENGTH OF TIME THE EMPLOYMENT IS TO CONTINUE AND THE SPECIAL SUBJECT OR SUBJECTS OF LEGISLATION TO WHICH THE EMPLOYMENT RELATES, TOGETHER WITH CIHER INFORMATION HEREINAFTER REQUIRED.
- "GENERAL ASSEMBLY" INCLUDES ANY MEMBER, CCMMITTEE OR SUBCOMMITTEE OF THE GENERAL ASSEMBLY OR OF THE LEGISLATIVE POLICY COMMITTEE OR ANY COMMITTEE OR SUBCOMMITTEE THEREOF.

6.

THE PROVISIONS OF THIS ARTICLE SHALL NCT AFFLY TO:

- PERSONS PERFORMING PROFESSIONAL SERVICES DRAFTING BILLS OR IN ADVISING AND RENDERING CPINIONS TO CLIENTS AS TO THE CONSTRUCTION AND EFFECT OF PROPOSED OR PENDING LEGISLATION WHERE SUCH SERVICES DO NOT CTHERWISE CONSTITUTE ACTIVITIES AS A LEGISLATIVE AGENT.
- (B) PERSONS APPEARING BEFORE A LEGISLATIVE COMMITTEE OR THE LEGISLATIVE POLICY COMMITTEE AND ANY COMMITTEE OR SUBCOMMITTEE THEREOF AT THE SPECIFIC INVITATION OR REQUEST OF THE COMMITTEE AND WHO ENGAGE IN NO FURTHER OR OTHER ACTIVITIES IN CONNECTION WITH THE PASSAGE OR DEFEAT OF LEGISLATION.
- (C) PERSONS APPEARING ONLY AND SOLELY CN MATTERS
 PERTAINING TO THEIR OFFICIAL DUTIES AS DULY ELECTED OR APPOINTED OFFICIALS OR EMPLOYEES OF THE STATE OR POLITICAL SUBDIVISION THEREOF OR CF THE UNITED STATES, AND NOT AS REPRESENTATIVES, IN ANY MANNER, CF ANY OTHER ENTITY.

7.

EVERY EMPLOYER SHALL FURNISH A WRITTEN AND SIGNED AUTHORIZATION TO ACT WHICH SHALL BE FILED WITH THE SECRETARY OF STATE BY THE LEGISLATIVE AGENT AT THE TIME OF HIS REGISTRATION. IF THE EMPLOYER IS A CCEPOFATION, AUTHORIZED OFFICER OR AGENT, WHO IS NOT THE LEGISLATIVE AGENT, SHALL FURNISH AND SIGN THE WRITTEN AUTHORIZATION. THE AUTHORIZATION SHALL INCLUDE THE FULL AND LEGAL NAME AND BUSINESS ADDRESS OF BOTH THE EMPLOYER AND THE LEGISLATIVE AGENT, THE FERICO CF TIME DURING WHICH THE LEGISLATIVE AGENT IS AUTHORIZED TO ACT, UNLESS SCONER TERMINATED, AND THE PROPESAL OR SUBJECTS UPON WHICH THE EMPLOYER IS REPRESENTED.
