THE COMMISSION MAY MODIFY ITS FINDINGS MAY SEEM PROPER. TO THE FACTS BY REASON OF THE ADDITIONAL EVIDENCE SO TAKEN, AND IT SHALL FILE WITH THE COURT SUCH MODIFIED OR NEW PINDINGS. WHICH IP SUPPORTED BY SUBSTANTIAL EVIDENCE. SHALL BE CONCLUSIVE, AND ITS RECOMMENDATION, IF ANY, FOR THE MODIFICATION OR SETTING ASIDE OF THE ORIGINAL ORDER. COURT MAY AFFIRM OR SET ASIDE ANY SUCH ORDER OF THE THE COMMISSION, AND STATE THE REASONS THEREFOR, AND SUCH JUDGMENT SHALL BE FINAL, SUBJECT TO REVIEW BY THE SUPREME THE UNITED STATES UPON CERTIORARI OR OF IN §§ 239 AND 240 OF CERTIFICATION AS PROVIDED THE JUDICIAL CODE, AS AMENDED (U.S.C. TITLE 28, §§ 346 AND 347) .

(B) STAY OF COMMISSION'S ORDER.

THE COMMENCEMENT OF PROCEETINGS UNDER SUBSECTION (A) OF THIS SECTION SHALL NOT, UNLESS SPECIFICALLY CRDERED BY THE COURT, OPERATE AS A STAY OF THE COMMISSION'S ORDER.

(C) IMMUNITY OF COMMISSION, ITS MEMBERS, OFFICERS, ETC., TO COSTS AND ACTIONS.

COMMISSION SHALL NOT, NOR SHALL ANY OF ITS MEMBERS, OFFICERS, AGENTS, OR EMPLOYEES, BE TAXED WITH NOR SHALL THEY OR ANY OF THEM BE REQUIRED TO COSTS. GIVE ANY SUPERSEDEAS BOND OR SECURITY FOR COST OR DAMAGES ON ANY APPEAL WHATSOEVER TAKEN UNDER THIS COMPACT. SAID COMMISSION, OR ANY OF ITS MEMBERS, OFFICERS, AGENTS, EMPLOYEES. SHALL NOT BE LIABLE TO SUIT OR ACTION CR FOR ANY JUDGMENT OR DECREE FOR ANY DAMAGES, LOSS, OR CLAIMED BY ANY PERSON RESULTING FROM ACTION TAKEN UNDER THIS COMPACT, NOR REQUIRED IN ANY CASE ARISING UNDER THIS COMPACT TO MAKE ANY DEPOSIT FOR COSTS OR PAY FOR ANY TO THE CLERKS OF ANY COURT OR TO THE MARSHAL OF SERVICE THE UNITED STATES.

18. ENFORCEMENT OF COMPACT: PENALTY FOR VIOLATIONS.

(A) ACTION TO ENJOIN VIOLATION.

WHENEVER IT SHALL APPEAR TO THE COMMISSION THAT PERSON IS ENGAGED OR ABOUT TO ENGAGE IN ANY ACTS OR PRACTICES WHICH CONSTITUTE OR WILL CONSTITUTE A VIOLATION OF THE PROVISIONS OF THIS COMPACT, OR OF ANY IT MAY, THEREUNDER, REGULATION, OR ORDER IN ITS DISCRETION, BRING AN ACTION IN THE UNITED STATES DISTRICT COURT FOR ANY DISTRICT IN WHICH SUCH PERSON RESIDES OR CARRIES ON BUSINESS OR IN WHICH THE VIOLATION OCCURRED. TO e njoi n SUCH ACTS OR PRACTICES AND TO WITH THIS COMPACT OR ANY RULE, REGULATION OR COMPLIANCE ORDER THEREUNDER, AND UPON A PROPER SHOWING A PERMANENT TEMPORARY INJUNCTION OR DECREE OR RESTRAINING ORDER SHALL BE GRANTED WITHOUT BOND.

(B) JURISDICTION.

UPON APPLICATION OF THE COMMISSION, THE UNITED
