

12-115. DISTRIBUTION OF SUMMARY OF LAWS; PUBLICATION OF TEXT OF LAWS, RULES, AND REGULATIONS.

(A) DISTRIBUTION OF SUMMARY.

THE ADMINISTRATION MAY PUBLISH A SUMMARY OF THE LAWS OF THIS STATE THAT RELATE TO THE OPERATION OF VEHICLES AND MAY GIVE A COPY OF THE SUMMARY, WITHOUT CHARGE, WITH EACH ORIGINAL VEHICLE REGISTRATION AND ORIGINAL DRIVER'S LICENSE THAT IT ISSUES.

(B) PUBLICATION OF TEXT.

(1) THE ADMINISTRATION MAY PUBLISH COPIES OF THE MARYLAND VEHICLE LAW AND RELATED LAWS AND OF THE RULES AND REGULATIONS ADOPTED UNDER THOSE LAWS, WHICH SHALL BE MADE AVAILABLE TO THE PUBLIC ON REQUEST.

(2) THE ADMINISTRATION SHALL CHARGE A PRICE FOR EACH COPY, NOT TO EXCEED THE COST OF ITS PREPARATION, PUBLICATION, AND MAILING. HOWEVER, COPIES OF THE LAWS, RULES, AND REGULATIONS MAY BE GIVEN FREE OF CHARGE TO LAW ENFORCEMENT AGENCIES AND THE COURTS OF THIS STATE.

12-116. SERVICE CHARGE FOR BAD CHECKS.

IF ANY PERSON GIVES A CHECK TO THE ADMINISTRATION TO PAY FOR ANY CHARGE OR FOR ANY OTHER PURPOSE AND THE CHECK IS NOT HONORED BY THE BANK ON WHICH IT IS DRAWN, THE ADMINISTRATION MAY IMPOSE A SERVICE CHARGE EQUAL TO THE GREATER OF:

(1) 10 PERCENT OF THE AMOUNT OF THE CHECK; OR

(2) \$5.

12-117. INTERFERENCE WITH PERSONS DOING BUSINESS; UNAUTHORIZED SOLICITATIONS.

IN OR NEAR ANY BUILDING OR PROPERTY USED BY THE ADMINISTRATION FOR ITS BUSINESS, A PERSON MAY NOT:
