

(B) TYPE I SCHOOL VEHICLES.

(1) IF IT IS ONLY OPERATED FOR THE TRANSPORTATION OF CHILDREN, STUDENTS, OR TEACHERS FOR EDUCATIONAL PURPOSES OR IN CONNECTION WITH A SCHOOL ACTIVITY, A TYPE I SCHOOL VEHICLE (SCHOOL BUS) SHALL:

(I) DISPLAY DISTINCTIVE "SCHOOL BUS" REGISTRATION PLATES ISSUED BY THE ADMINISTRATION; AND

(II) COMPLY WITH ALL THE REQUIREMENTS OF THE MARYLAND VEHICLE LAW AND THE REGULATIONS OF THE ADMINISTRATION THAT RELATE TO A TYPE I SCHOOL VEHICLE.

(2) IF IT IS OPERATED FOR ANY PURPOSE IN ADDITION TO THE TRANSPORTATION OF CHILDREN, STUDENTS, OR TEACHERS FOR EDUCATIONAL PURPOSES OR IN CONNECTION WITH A SCHOOL ACTIVITY, A TYPE I SCHOOL VEHICLE (SCHOOL BUS) SHALL DISPLAY DISTINCTIVE "SCHOOL CHARTER" REGISTRATION PLATES ISSUED BY THE ADMINISTRATION.

(3) THE ADMINISTRATION SHALL ISSUE "SCHOOL CHARTER" PLATES:

(I) IN PLACE OF AND NOT IN ADDITION TO "SCHOOL BUS" PLATES; AND

(II) ONLY TO VEHICLES COMPLYING WITH ALL THE REQUIREMENTS OF THE MARYLAND VEHICLE LAW AND THE REGULATIONS OF THE ADMINISTRATION THAT RELATE TO A TYPE I SCHOOL VEHICLE.

(C) TYPE II SCHOOL VEHICLES.

A TYPE II SCHOOL VEHICLE SHALL:

(1) DISPLAY DISTINCTIVE REGISTRATION PLATES ISSUED BY THE ADMINISTRATION; AND

(2) COMPLY WITH ALL THE REQUIREMENTS OF THE MARYLAND VEHICLE LAW AND THE REGULATIONS OF THE ADMINISTRATION THAT RELATE TO A TYPE II SCHOOL VEHICLE.
