16-116. NOTICE OF CHANGE OF ADDRESS OR NAME.

(A) NOTICE OF CHANGE.

IF ANY INDIVIDUAL WHO HAS APPLIED FOR OR OBTAINED A DRIVER'S LICENSE UNDER THIS SUBTITLE MOVES FROM THE ADDRESS GIVEN IN THE APPLICATION OR SHOWN ON THE LICENSE OR IF HIS NAME IS LATER CHANGED BY MARRIAGE OR COURT ORDER, HE SHALL, WITHIN 30 DAYS OF THE CHANGE, NOTIFY THE ADMINISTRATION IN WRITING OF:

- (1) THE FORMER ADDRESS AND NEW ADDRESS OR THE FORMER NAME AND NEW NAME; AND
- (2) THE IDENTIFYING NUMBER OF ANY LICENSE ISSUED TO HIM.
- (B) ADMINISTRATION MAY REQUEST CLD LICENSE IF NAME CHANGED.

ON REQUEST OF THE ADMINISTRATION, IF THE NAME OF A LICENSEE HAS BEEN CHANGED, THE LICENSEE SHALL SURRENDER HIS DRIVER'S LICENSE TO THE ADMINISTRATION. AFTER IT RECEIVES THE LICENSE, THE ADMINISTRATION SHALL ISSUE A CORRECTED LICENSE IN THE NEW NAME.

(C) TEMPORARY LICENSE.

IF A LICENSEE IS REQUIRED TO SURRENDER HIS LICENSE TO THE ADMINISTRATION TO RECORD A CHANGE, THE ADMINISTRATION SHALL ISSUE HIM, WITHOUT CHARGE, A TEMPORARY LICENSE VALID FOR NCT MORE THAN 20 DAYS FROM THE DATE IT IS ISSUED.

(D) SECTION INAPPLICABLE TO EXPIRED LICENSES.

THIS SECTION DOES NOT APPLY TO AN EXPIRED LICENSE.
