

## (3) "PUBLIC BUILDING" MEANS:

~~(I) ANY BUILDING THAT IS OPEN TO THE PUBLIC DURING NORMAL BUSINESS HOURS;~~

~~(II) ANY BUILDING THAT PROVIDES FACILITIES OR SHELTER FOR PUBLIC ASSEMBLY;~~

~~(III) ANY BUILDING THAT IS USED FOR EDUCATIONAL, OFFICE, OR INSTITUTIONAL SPACE;~~

~~(IV) ANY COMMERCIAL ESTABLISHMENT THAT PROVIDES SERVICES OR RETAILS MERCHANDISE, INCLUDING ANY INN, HOTEL, MOTEL, SPORTS ARENA, SUPERMARKET, TRANSPORTATION TERMINAL, RETAIL STORE, OR RESTAURANT;~~

~~(V) ANY BUILDING THAT A STATE OR POLITICAL SUBDIVISION OF A STATE OWNS, INCLUDING ANY LIBRARY, MUSEUM, SCHOOL, HOSPITAL, AUDITORIUM, SPORTS ARENA, OR UNIVERSITY BUILDING; AND~~

~~(VI) ANY PORTION OF AN INDUSTRIAL PLANT BUILDING THAT IS USED PRIMARILY AS OFFICE SPACE OWNED BY THE STATE OR ANY COUNTY OR MUNICIPAL GOVERNMENT OR ANY AGENCY THEREOF;~~

~~(VII) (II) THE PROVISIONS OF THIS ACT SHALL APPLY TO ALL PUBLIC BUILDINGS, AS DEFINED, WHICH ARE 10,000 OR MORE SQUARE FEET IN AREA, PER FLOOR.~~

(B) (1) THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, IN CONJUNCTION WITH THE DEPARTMENT OF NATURAL RESOURCES, SHALL DEVELOP GUIDELINES FOR RECOMMENDED ILLUMINATION LEVELS IN EXISTING PUBLIC BUILDINGS IN MARYLAND 6 MONTHS AFTER ASHRAE 100 STANDARDS ARE PROMULGATED.

(2) AFTER APPROVAL BY THE AELR COMMITTEE OF THE MARYLAND GENERAL ASSEMBLY, THESE GUIDELINES WILL BE PUBLISHED IN THE MARYLAND REGISTER AND OTHER APPROPRIATE MEDIA IN ORDER TO ENCOURAGE THEIR USE AND TO OFFER GUIDELINES AGAINST WHICH OWNERS AND/OR OPERATORS OF EXISTING PUBLIC BUILDINGS, INCLUDING LOCAL GOVERNMENTS, THE DEPARTMENT OF GENERAL SERVICES, AND OTHER AGENCIES WHICH MANAGE STATE BUILDINGS, MAY TARGET THEIR ENERGY CONSERVATION EFFORT WITH REGARD TO ILLUMINATION.

(C) (1) THERE IS AN ADVISORY COMMISSION ON ENERGY CONSERVATION IN BUILDINGS.

(2) THE SECRETARY OF ECONOMIC AND COMMUNITY DEVELOPMENT SHALL APPOINT 15 MEMBERS OF THE ADVISORY COMMISSION. THE MEMBERS SHALL SERVE WITHOUT COMPENSATION AND SHALL BE REIMBURSED FOR EXPENSES IN ACCORDANCE WITH THE STANDARD TRAVEL REGULATIONS.

(3) MEMBERS APPOINTED SHALL BE BROADLY REPRESENTATIVE AND SHALL INCLUDE REPRESENTATIVES FROM STATE AND LOCAL CODE ENFORCEMENT AGENCIES, ARCHITECTURAL AND
