

COMPLETED TRAINING IN AND IS LICENSED IN THIS STATE AS A JOURNEYMAN BARBER SHALL BE GIVEN 50 PERCENT CREDIT TOWARDS MEETING THE REQUIREMENTS OF PARAGRAPH (1). SUBJECT TO SECTION 536(A) (6) OF THIS SUBTITLE, THE BOARD SHALL DETERMINE THE MANNER IN WHICH THE CREDITS ARE APPLIED.

536.

(A) A SCHOOL OF BEAUTY CULTURE MAY NOT BE GRANTED A CERTIFICATE OF REGISTRATION UNLESS IT SHALL:

(1) ATTACH TO ITS STAFF, AS A CONSULTANT, A PERSON LICENSED BY THIS STATE TO PRACTICE MEDICINE;

(2) EMPLOY AND MAINTAIN A SUFFICIENT NUMBER OF LICENSED TEACHERS, REGISTERED AS SUCH;

(3) POSSESS APPARATUS AND EQUIPMENT SUFFICIENT FOR THE PROPER AND FULL TEACHING OF ALL SUBJECTS OF ITS CURRICULUM;

(4) KEEP A DAILY RECORD OF THE ATTENDANCE OF EACH STUDENT, MAINTAIN REGULAR CLASS AND INSTRUCTION HOURS, AND ESTABLISH GRADES AND HOLD EXAMINATIONS BEFORE ISSUANCE OF DIPLOMAS;

(5) PROVIDE AT LEAST ONE SENIOR TEACHER FOR EVERY 25 PUPILS IN ATTENDANCE AT ANY GIVEN TIME; AND

(6) (I) REQUIRE A DAY SCHOOL TERM OF TRAINING OF NOT LESS THAN 1,500 HOURS WITHIN A PERIOD OF NOT LESS THAN NINE CONSECUTIVE MONTHS, OR A NIGHT SCHOOL TERM OF TRAINING OF NOT LESS THAN 1,500 HOURS WITHIN A PERIOD OF NOT LESS THAN 18 CONSECUTIVE MONTHS FOR A COMPLETE COURSE, COMPRISING ALL OR A MAJORITY OF THE PRACTICES OF BEAUTY CULTURE, AS PROVIDED BY THIS SUBTITLE, AND TO INCLUDE PRACTICAL DEMONSTRATIONS AND THEORETICAL STUDIES, AND STUDY IN SANITATION, STERILIZATION, AND THE USE OF ANTISEPTICS, COSMETICS, AND ELECTRICAL APPLIANCES, CONSISTENT WITH THE PRACTICAL AND THEORETICAL REQUIREMENTS AS APPLICABLE TO BEAUTY CULTURE OR ANY PRACTICE OF BEAUTY CULTURE.

(II) HOWEVER, SCHOOLS OF BEAUTY CULTURE SHALL GIVE CREDIT FOR 50 PERCENT OF THE TRAINING HOURS REQUIRED UNDER THIS SUBSECTION TO ANY PERSON ENROLLED IN THE SCHOOL WHO HAS PREVIOUSLY COMPLETED TRAINING IN AND IS CURRENTLY LICENSED AS A JOURNEYMAN BARBER IN THIS STATE.

(III) HOWEVER, IN PUBLIC VOCATIONAL SCHOOL COURSES OF COSMETOLOGY, COMPLETION OF THE PRESCRIBED 1,500 HOURS OF TRAINING SHALL BE ACCOMPLISHED WITHIN A PERIOD OF TIME DETERMINED BY THE BOARDS OF EDUCATION OF THE SEVERAL COUNTIES AND THE BOARD OF SCHOOL COMMISSIONERS OF BALTIMORE CITY.

(B) ANY SCHOOL LICENSED UNDER THIS SUBTITLE SHALL BE NAMED SO AS TO DESIGNATE THAT IT IS A SCHOOL OF BEAUTY CULTURE.
