5-305. SEPARATE ACCOUNTS FOR CONSTRUCTION FUNDS; SPECIAL PROVISION FOR ANNE ARUNDEL COUNTY.

(A) SEPARATE ACCOUNTS REQUIRED FOR CONSTRUCTION FUNDS.

EACH COUNTY BOARD SHALL KEEP:

(1) ALL MONEY FOR THE CONSTRUCTION OF PUBLIC SCHOOL BUILDINGS AND PUBLIC SCHOOL FACILITIES AND THE PURCHASE OF LAND FOR PUBLIC SCHOOLS IN A SEPARATE ACCOUNT FROM THAT USED FOR CURRENT EXPENSES; AND

(2) A SEPARATE AND INDEPENDENT ACCOUNTING SYSTEM FOR ALL PUBLIC SCHOOL CONSTRUCTION MONEY.

(B) ANNE ARUNDEL COUNTY.

(1) IN ANNE ARUNDEL COUNTY, THE COUNTY BOARD MAY BORROW FROM ONE FUND TO MEET TEMPORARY CASH REQUIREMENTS OF ANOTHER FUND OR TO REIMBURSE ANOTHER FUND FOR SERVICES PERFORMED.

(2) THIS BORROWING OR REIMBURSEMENT IS SUBJECT TO THE COUNTY CHARTER.

5-306. MONTGOMERY COUNTY 6-YEAR CAPITAL IMPROVEMENTS PROGRAM.

(A) SECTION IS SUPPLEMENTARY TO §§ 5-101 THROUGH 5-107 OF THIS TITLE.

THIS SECTION SUPPLEMENTS THE PROVISIONS OF §§ 5-101 THROUGH 5-107 OF THIS TITLE AND DOES NOT SUPERSEDE OR IMPAIR THOSE PROVISIONS.

(B) COUNTY SUPERINTENDENT TO PREPARE 6-YEAR CAPITAL IMPROVEMENTS PROGRAM.

BEFORE DECEMBER 15 OF EACH YEAR, THE MONTGOMERY COUNTY SUPERINTENDENT SHALL PREPARE AND SUBMIT TO THE MONTGOMERY COUNTY EXECUTIVE A 6-YEAR CAPITAL IMPROVEMENTS PROGRAM.
