for each day or fraction thereof that they shall pursue the business—of—moving-picture-machine-operator in the City of Baltimore; and if said-fine is not paid, shall be subject to imprisonment for thirty-days or both at the discretion of the judge.

If-any-such-person-decires to-engage-or-continue-in-the business-of-moving--picture-machine-operator,-after-May-1, 1910, he shall apply to the Board provided for in Section 11-3,-for-a license and submit to an examination as to his qualification-before-th∈-Board, and,-if-found-profisient-by the Board, they shall issue a license, otherwise they shall refuse-to-grant-a-license;-if-the-Board-shall-find,--after due--examination, that-the-applicant-for-a-license-possesses a reasonable knowledge of the soving picture machine operator-business-and-electricity, as-pertains to the operation-and-management-of-moving-picture-mackines,-then the Board shall, upon payment of the fee herein provided for, issue to the applicant a license for a term of not more than-one-year, and shall keep-a record of all licenses so issued; and no person shall be granted a lisense who has not reached the age of 21 years, and makes out he the fact, and has had at least six months experience under a licensed operator: provided-that-each-applicant-for-the-license-shall pay to the Board a license fee of twenty - dellars (\$20.00) -The license is to be good for a term of one year, and at the expiration of the term a renewal shall be issued by the Board-upon the payment of a fee of ten dollars (\$10.00) for the renewal. No person granted a license under the provisions of the subheading shall-operate a moving -pioture machine-after-the-expiration-of-the-license-or-after-the license shall have been suspended or revoked as herein provided, --unless -- the -- the -- the -- transcore -- renewal - of -same - shall have been granted as herein provided.

11-6-

Any-person-desiring-to-operate-moving-picture-machines, without-compensation, for state, religious or charitable institutions—exclusively, may obtain a restricted license therefor—on-passage—of—the—usual—examination, without payment—of—the—original or renewal license fees of \$10.00 and \$5.00, respectively.—Such license—shall not—entitle such—operator—to—operate—for compensation—or otherwise as expressly-herein-specified.

Any-person-taking-a-false-oath-in-reference-to-his-age or time-that-he-has-operated-under-a-licensed-operator, or length-of-time-that-he-has-operated-a-moving-picture machine, shall-be-decmed-guilty-of-perjury, and upon conviction-in-the-Criminal-Court-of-Baltimore-City-be-fined not-less-than-fifty-dollars-(\$50.00) nor-more-than-one hundred-dcllare-(\$100.00) --hry-person-failing-to-pass-an examination-shall-nct-be-permitted-to-retake-it-within-six
