county shall be good and sufficient as a license to offer for sale in every part of the State[; provided that].

- (3) [such] A license [shall] DCES not authorize the holder thereof to open or carry on any store or fixed place of business for such selling or offering for sale in any place other than in the place of business designated in [said] THE license and in the application therefor, it being intended [hereby] that a separate trader's license shall be obtained for each store or fixed place of business[; but no].
- (B) (1) A license to trade or to sell spirituous or fermented liquors [shall] MAY NOT be issued by any clerk of a court to any person under the age of eighteen years, without the special crder of a judge of [said] THE court[; and no judges shall].
- (2) A JUDGE MAY NOT give [such] A special order to issue [such] A license to sell spirituous or fermented liquors to a person under age of eighteen years, unless upon the recommendation of at least ten respectable freeholders residents of the ward or district wherein [said] THE license would be operative[; and whenever].
