- (C) ANY INSURANCE POLICY ISSUED IN ACCORDANCE WITH THIS SECTION MAY NOT REQUIRE THAT, AS A CONDITION FOR THE PAYMENT OF BENEFITS, THE NURSE MIDWIFE MUST BE EMPLOYED BY A PHYSICIAN OR MUST ACT PURSUANT TO A PHYSICIAN'S ORDERS.
- (D) AFTER JULY 1, 1979 A NCNPROFIT HEALTH INSURER SHALL RENEW, MODIFY, ALTER, AMEND, OR REISSUE ANY EXISTING HEALTH INSURANCE FOLICY TO INCLUDE OFFER THE OPTION OF PROVIDING BENEFITS FOR EXPENSES ARISING FROM CARE, TREATMENT, OR SERVICES BENDERED BY A NURSE MIDWIFE.
- (E) UTILIZATION OF NONPROFIT HEALTH INSURANCE BENEFITS BY A NURSE MIDWIFE IS SUBJECT TO REVIEW BY A PEER REVIEW COMMITTEE APPOINTED BY THE STATE BOARD OF EXAMINERS OF NURSES.
- NOTWITHSTANDING ANY PROVISION OF A GROUP OR (F) INDIVIDUAL POLICY, OR CONTRACT, OR ANY CERTIFICATE ISSUED THEREUNDER, OF HEALTH AND/OR SICKNESS, AND/OR ACCIDENT, AND/OR DISABILITY INSURANCE, DELIVERED WITHIN THE STATE, OR ISSUED TO A GROUP WHICH IS INCORPORATED OR HAS A MAIN OFFICE LOCATED IN THE STATE, OF COVERING PERSONS WHO RESIDE OR WORK WITHIN THE STATE, WHENEVER SUCH POLICY, CONTRACT, OR CERTIFICATE PROVIDES FOR REIMBURSEMENT FOR ANY SERVICE WHICH IS WITHIN THE LAWFUI SCOPE OF PRACTICE OF A DULY CERTIFIED NURSE MIDWIFE, THE INSURED, OR ANY CTHER PERSON COVERED BY THE POLICY, CONTRACT, OR CERTIFICATE, SHALL BE ENTITLED TO REIMEURSEMENT FOR SUCH SERVICE. WHETHER THE SERVICE IS PERFORMED BY A DOCTOR OF MEDICINE OR A DULY CERTIFIED NURSE MIDWIFE. THE PROVISIONS OF THIS SECTION SHALL APPLY TO ALL SUCH FCLICIES, CCNTRACTS, OR CERTIFICATES ISSUED, RENEWED, MODIFIED, ALTERED, AMENCED, OR REISSUED ON OR AFTER JULY 1, 1979.

- (A) IN THIS SECTION "NURSE MIDWIFE" MEANS A LICENSED REGISTERED NURSE WHO HAS BEEN CERTIFIED BY THE AMERICAN COLLEGE OF NURSE-MIDWIVES AS A NURSE MIDWIPE.
- (F) AFTER JULY 1, 1979 EVERY HEALTH INSURER WHO PROPOSES TO ISSUE, RENEW, MODIFY, ALTER, AMEND, OR REISSUE ANY HEALTH INSUBANCE PCIICY IN MARYLAND WHICH IS WRITTEN ON AN EXFENSE INCURRED FASIS SHALL INCLUDE OFFER THE OPTION OF PROVIDING BENEFITS FOR EXPENSES ARISING FROM CARE, TREATMENT, OR SERVICES BENDERED BY A NURSE MIDWIFE.
- (C) ANY INSURANCE POLICY ISSUED IN ACCORDANCE WITH THIS SECTION MAY NCT REQUIRE THAT, AS A CONDITION FOR THE PAYMENT OF BENEFIIS, THE NURSE MIDWIFE MUST BE EMPLOYED BY A PHYSICIAN OR MUST ACT FURSUANT TO A PHYSICIAN'S ORDERS.
- (D) AFTER JULY 1, 1979 A HEALTH INSURER SHALL RENEW, MODIFY, ALTER, AMENC, OR REISSUE ANY EXISTING HEALTH
