beer, wine, and liquor licensee to sell beer between the hours of 8:00 a.m. and 10:00 p.m. on Sundays[; and between] BFTWEEN the hours of 12:30 o'clock p.m. and 10:00 o'clock p.m. on Sunday it [shall be] IS lawful for a Class B or C, beer licensee to sell keer and for a Class B or C beer, wine and liquor licensee, to sell beer, wine and liquor, provided that these alcoholic beverages are consumed on the premises.

- (4) In Allegany County, however, Sunday sales when New Year's Eve or New Year's Day fall on a Sunday shall be governed by § 89(i) of this article.
- (5) In Garrett County, however, Sunday sales when New Year's Eve or New Year's Day fall on a Sunday shall be governed by § 89(j) cf this article.

- (A) In Kent County, notwithstanding any other provision of this subtitle, it is unlawful for any person to sell or for any retail dealer to give alcoholic beverages between the hours of midnight on Saturday and 6:00 a.m. on Monday, except as to (1) Class C, beer, wine and liquor license (on-sale) club under which it is lawful to keep for and sell in Kent County, for consumption on the licensed premises alcoholic beverages on Sunday between the hours of 1:00 p.m. and midnight; [and] (2) Class A, beer and wine license under which it is lawful to sell between 9:00 a.m. Sunday and 2:00 a.m. the following day; AND (3) CLASS A, B, AND C BEER, WINE, AND LIQUOR LICENSE UNDER WHICH IT IS LAWFUL TO SELL BEER AND LIGHT WINE ONLY, FOR CONSUMPTION OFF THE LICENSED PREMISES, ON SUNDAY BETWEEN 9 A.M. AND 2 A.M. THE FOLICWING DAY. Also on Sunday between the hours of 1:00 p.m. and midnight, bona fide restaurants holding a Class B beer, wine and liquor license are permitted to serve alcoholic beverages for consumption on the premises only as a supplement to meals (which requires that the total alcoholic beverage kill cannot exceed the total price of the meal) and only when seated at a table (and not from a bar or bar stools). The word "restaurant" when applied to Kent County, means a business establishment for the accommodation the public, fully equipped with a proper and adequate dining room and with sufficient facilities for preparing and serving meals, which has been approved by the board of license commissioners of Kent County, wherein the average daily receipts from the sale of food comprise at least 60 percent of the average daily receipts of the business.
- (E) Any person selling or any retail dealer giving alcoholic beverages in Kent County between the hours of midnight on Saturday and 6:00 a.m. on Monday, except as to Class A, B and C licenses, is guilty of a misdemeanor and[, uron conviction is] MAY BE fined not [exceeding] MORE THAN \$50 for the first offense, and [for each succeeding offense is fined] not [exceeding] MORE THAN \$100 or imprisoned in the county jail for not more than 30 days, or [be] both [fined and imprisoned, in the discretion of the court] FOR EACH SUCCEEDING OFFENSE.
