(2) IN ADDITION, ANY PERSON WHO KNOWINGLY VIOLATES THIS SECTION IS GUILTY OF A MISDEMBANOR AND UPON GENVICTION SHALL BE FINED NOT MORE THAN \$1,000. ANY DAMAGES RECOVERABLE IN LAW OR EQUITY INCLUDING REASONABLE ATTORNEY'S FEES.

- (A) A NONPEOFIT HEALTH SERVICE PLAN MAY REVEAL SPECIFIC MEDICAL INFORMATION CONTAINED IN A SUBSCRIBER'S MEDICAL RECORDS TO THE SUBSCRIBER OR HIS AGENT OR REPRESENTATIVE.
- (E) A NONPROFIT BEALTH SERVICE PLAN MAY NOT REVEAL SPECIFIC MEDICAL INFCHMATION CONTAINED IN A SUBSCRIBER'S MEDICAL RECORDS TO ANY FERSON UNLESS:
 - (1) IT IS AUTHORIZED BY THE SUBSCRIBER: OR
- (2) IT IS FROVIDING INFORMATION REQUESTED BY OR IN FURTHERANCE OF THE PURPOSE OF A MEDICAL REVIEW COMMITTEE, ACCREDITATION BOARD, OR COMMISSION, OR IN RESPONSE TO LEGAL PROCESS; OR
- (3) IT IS FURNISHING INFORMATION TO ANOTHER NCNPROFIT HEALTH SERVICE PLAN, OR BLUE CROSS OR BLUE SHIELD PLAN,—GR—AN—INSURANCE—COMPANY FOR THE PURPOSE OF COORDINATING BENEFIT PAYMENTS UNDER MORE THAN ONE SICKNESS AND ACCIDENT, DENTAL, CR HOSPITAL MEDICAL INSURANCE—POLICY OTHER—THAN AN INDIVIDUAL—POLICY CONTRACT; OR
- (4) IT IS FROVIDING INFORMATION TO GOVERNMENTAL AGENCIES IN THE PERFORMANCE OF THEIR LAWFUL DUTIES AS AUTHORIZED BY AN ACT CF THE GENERAL ASSEMBLY OR THE UNITED STATES CONGRESS; OR
- (5) WHEN PROVIDING INFORMATION AT THE REQUEST OF A FESEARCHER FOR THE PURPOSE OF MEDICAL AND HEALTH CARE RESEARCH PURSUANT TO A PROTOCOL APPROVED BY AN INSTITUTIONAL REVIEW EDARC.
- (C) (1) A NCNFROFIT HEALTH SERVICE PLAN WHICH KNOWINGLY VIOLATES THIS SECTION SHALL BE LIABLE TO ANY PLAINTIFF FCR \pm
