

In revising this title, the Commission to Revise the Annotated Code deleted as unnecessary the provisions of Article 77, §160(n). This subsection provides for the severability of the provisions of §160 and is deleted in light of Article 1, §23 providing for the severability of all statutes enacted after July 1, 1973.

**TITLE 7. PUBLIC SCHOOLS.**

**SUBTITLE 1. GENERAL PROVISIONS.**

**7-101. ADMISSION OF STUDENTS; KINDERGARTEN PROGRAMS.**

**(A) ADMISSIONS.**

ALL INDIVIDUALS WHO ARE 5 YEARS OLD OR OLDER AND UNDER 21 SHALL BE ADMITTED FREE OF CHARGE TO THE PUBLIC SCHOOLS OF THIS STATE.

**(B) KINDERGARTENS.**

THERE SHALL BE FULL KINDERGARTEN PROGRAMS IN EACH COUNTY OF THIS STATE.

**7-102. DISCLOSURE AFFIDAVITS FOR PARENTS OF CHILDREN ENTERING PRINCE GEORGE'S COUNTY SCHOOLS.**

**(A) COUNTY BOARD TO DEVELOP FORM.**

THE PRINCE GEORGE'S COUNTY BOARD SHALL DEVELOP AN AFFIDAVIT OF DISCLOSURE FORM TO BE COMPLETED AND SIGNED BY THE PARENTS OR GUARDIANS OF A STUDENT WHO IS ENTERING THE PUBLIC SCHOOLS OF PRINCE GEORGE'S COUNTY.

**(B) COMPLETION OF DISCLOSURE FORM PREREQUISITE TO ADMISSION.**

BY REGULATION, THE COUNTY BOARD SHALL MAKE COMPLETION OF AN AFFIDAVIT OF DISCLOSURE A PREREQUISITE FOR ADMISSION TO THE PUBLIC SCHOOLS, EXCEPT THAT PARENTS AND GUARDIANS WHO ARE NEWLY ARRIVED RESIDENTS SHALL BE ALLOWED 30 DAYS AFTER ENROLLMENT, IF NECESSARY, TO COMPLETE THE AFFIDAVIT.

**(C) DISCLOSURE LIMITED TO ASCERTAINING RESIDENCY.**

THE PURPOSE OF THE AFFIDAVIT OF DISCLOSURE IS LIMITED
