SECTION 1. BE II FNACTED BY THE GENERAL ASSEMBLY OF MARYLAND, That section(s) of the Annotated Code of Maryland be repealed, amended, or enacted to read as follows:

Article 2E - Alcoholic Beverages

- (J) (1) IT SHALL BE UNLAWFUL IN CECIL COUNTY FOR ANY "BOTTIE CLUE" AS FEREIN DEFINED OR OTHER PUBLIC CLUB, BCCM, CB FREMISES WHICH IS TO BE USED OR IS USED AS A "BOTTLE CLUE" SO AS TC EVADE THE ALCOHOLIC BEVERAGE LICENSE LAWS OR HOURS OF OPERATION, TO SELL, GIVE, SERVE, DISPENSE, KEEP, OR ALLOW TO BE CONSUMED ON ITS PREMISES OR ON PREMISES UNDER ITS CONTROL OR POSSESSION ANY ALCOHOLIC BEVERAGE, SETUPS, CR OTHER COMEONENT PARTS OF MIXED ALCOHOLIC DRINKS.
- ## BOTTLE CLUB" SHALL MEAN ANY CLUB WHICH SERVES, SELLS, GIVES, OR DISFENSES ALCCHOLIC BEVERAGES TO ITS MEMBERS OR GUESTS, OR WHICH KEEFS FOR ITS MEMBERS OR GUESTS ANY ALCOHOLIC BEVERAGES, EY ITS MEMBERS OR GUESTS, WHICH BEVERAGES, OR WHICH ALLOWS TO BE CONSUMED ON ITS PREMISES ANY ALCOHOLIC BEVERAGES, EY ITS MEMBERS OR GUESTS, WHICH BEVERAGES HAVE BEEN RESERVED OR PURCHASED BY THE MEMBERS OR GUESTS; OR ANY CLUB AT WHICH PATRONS ARE SERVED, GIVEN, OF ALLOWED TO CONSUME ALCOHOLIC BEVERAGES AFTER LEGAL CLOSING HOURS FROM THE SUPPLIES THAT THE PATRONS HAVE PREVIOUSLY PURCHASED OR RESERVED; OR ANY CLUB THAT SELLS, DISPENSES, SERVES, KEEPS, OR ALLOWS TO BE CONSUMED ANY SETUPS OR OTHER COMFONENT PARTS OF MIXED ALCOHOLIC DRINKS TO ITS MEMBERS OR GUESTS.

- (a) In Anne Arundel County [and], Worcester County [and in], Harford County, AND CECIL COUNTY, any license issued under the provisions of this article shall be revoked if, after hearing as provided in § 70 of this subtitle, any of the following activities are found to occur on any premises or location for which the license was issued:
 - (1) With respect to attire and conduct:
- (i) Employment or use of any person in the sale or service of alcoholic beverages in or upon the licensed premises while the person is unclothed or in attire, costume or clothing so as to expose to view any portion of the female breast below the top of the areola or if any portion of the pubic hair, anus, cleft of the buttocks, vulva or genitals.
