- IN ADDITION TO THE OTHER RESTRICTIONS PROVIDED IN THIS SUPTITLE, THE ADMINISTRATION MAY ISSUE A PROVISIONAL DRIVER'S LICENSE TO APPLICANTS WHO ARE UNDER THE AGE OF 18. THE LICENSE MAY RESTRICT-THE-LICENSEE-TO-DRIVING-ONLY-DURING CERTAIN-HOURS BE RESTRICTED BY REQUIRING THAT THE LICENSEE BE ACCOMPANIED AND SUPERVISED AT CERTAIN TIMES BY A DRIVER WHO IS AT LEAST 21 YEARS OLD AND HAS BEEN LICENSED TO DRIVE FOR AT LEAST 3 YEARS LICENSED DRIVER WHO IS AT LEAST 21 YEARS OID. IF THE RESTRICTION WOULD AFFECT ADVERSELY THE EMPLOYMENT OR OFFORTUNITY FOR EMPLOYMENT OF THE LICENSEE THE ADMINISTRATOR HAY MODIFY OR WAIVE THE RESTRICTION.
- [(c)] (D) After receiving satisfactory evidence of violation of a [restriction on a] RESTRICTED OR PROVISIONAL driver's license, the Administration may suspend or revoke the license. However, the licensee may request a hearing as provided for a suspension or revocation under Subtitle 2 of this title.
- [(d)] (E) An individual may not drive a vehicle in any manner that viclates any restriction imposed in a restricted OR PROVISIONAL license issued to him.

- THE DRIVER'S LICENSE ISSUED SHALL BE AS PROVIDED IN § 16-111 OF THIS SUBTITLE, EXCEPT THAT IT SHALL BE IDENTIFIABLE AS A PROVISIONAL DRIVERS LICENSE AND SHALL CCNTAIN A PROVISIONAL SYMBOL LIMITING THE LICENSEE TO DRIVING UNSUPERVISED ONLY DURING GERTAIN HOURS. FROM 6:00 A.M. UNTIL 1:00 A.M.
- (C) A PROVISIONAL DRIVER'S LICENSE IS SUBJECT TO THE EXPIRATION AND RENEWAL REQUIREMENTS OF § 16-115 OF THIS SUBTITLE.
- (D) UPON MEETING THE REQUIREMENTS SET FORTH IN § 16-111.2(B) OF THIS SCHTITLE, OR UPON ATTAINING THE AGE OF 18, THE HOLDER OF A SPECIAL-RESTRICTED PROVISIONAL DRIVER'S LICENSE SHALL BE ISSUED A REGULAR DRIVER'S LICENSE AS PROVIDED IN § 16-111 CF THIS SUBTITLE.
- (E) THE REGULAR DRIVER'S LICENSE SHALL BE ISSUED WITHOUT PAYMENT OF AN AIDITIONAL FEE AND SHALL EXPIRE ON THE SAME DATE OF EXPIRATION SHOWN ON THE SPECIAL RESTRICTED PROVISIONAL DRIVER'S LICENSE BEING SURRENDERED.
