

(G) ON OR BEFORE THE EIGHTH DAY OF THE REGULAR SESSION OF THE GENERAL ASSEMBLY IN THE YEAR OF EVALUATION, THE DESIGNATED ~~COMMITTEES~~ COMMITTEE SHALL REPORT ~~TO THEIR RESPECTIVE HOUSES REGARDING THEIR~~ TO THE GENERAL ASSEMBLY ITS RECOMMENDATION TO REESTABLISH, RECONSTITUTE WITH CHANGES, REPEAL, OR ALLOW TO TERMINATE THE BOARD UNDER EVALUATION. THIS REPORT SHALL BE ACCOMPANIED BY A BILL TO EFFECT THE RECOMMENDATION, IF LEGISLATION IS APPROPRIATE.

487. COOPERATION OF BOARDS.

A BOARD WHICH IS SUBJECT TO EVALUATION UNDER THIS SUBTITLE SHALL UPON REQUEST, PROMPTLY SUPPLY THE DEPARTMENT OF FISCAL SERVICES AND THE REVIEWING COMMITTEES WITH ALL INFORMATION WHICH IS REQUESTED AND SHALL OTHERWISE COOPERATE WITH THE DEPARTMENT AND THE COMMITTEES IN THE EVALUATION.

488. TRANSITION.

(A) A MEMBER OF A BOARD THAT IS REESTABLISHED PURSUANT TO THIS ACT SHALL CONTINUE TO HOLD OFFICE FOR THE TERM FOR WHICH THE MEMBER WAS APPOINTED UNLESS THE LAW REESTABLISHING THE BOARD PROVIDES TO THE CONTRARY.

(B) THIS ACT SHALL NOT CAUSE THE DISMISSAL OF ANY CLAIM OR RIGHT OF A PERSON OR ENTITY AGAINST ANY BOARD, OR ANY CLAIM OR RIGHT OF A BOARD REPEALED UNDER THIS ACT, WHICH IS SUBJECT TO LITIGATION. THE STATE SHALL ASSUME ALL SUCH CLAIMS AND RIGHTS.

Article 10 - Attorneys at Law and Attorneys in Fact

8A.

THE PROVISIONS OF THIS SUBTITLE CREATING THE STATE BOARD OF LAW EXAMINERS AND RELATING TO THE REGULATION OF ATTORNEYS AND ANY REGULATIONS PROMULGATED UNDER THIS SUBTITLE ARE OF NO EFFECT AND MAY NOT BE ENFORCED AFTER JULY 1, 1984.

Article 11 - Banks and Trust Companies

26A.

THE PROVISIONS OF THIS SUBTITLE CREATING THE OFFICE OF BANK COMMISSIONER AND RELATING TO THE POWERS AND DUTIES OF THE COMMISSIONER AND THOSE PROVISIONS RELATING TO THE BANKING BOARD AND ANY REGULATIONS PROMULGATED UNDER THIS SUBTITLE ARE OF NO EFFECT AND MAY NOT BE ENFORCED AFTER JULY 1, 1982.

THE PROVISIONS OF THIS SUBTITLE CREATING THE BANKING BOARD AND RELATING TO THE REGULATION OF BANKS AND ANY REGULATIONS PROMULGATED UNDER THIS SUBTITLE ARE OF NO EFFECT AND MAY NOT BE ENFORCED AFTER JULY 1, 1982.
