

(as enacted by Chapter ____ of the Acts of the General Assembly of 1978) be repealed, amended, or enacted to read as follows:

Article - Education

16-407.

(a) (1) [Any] SUBJECT TO PARAGRAPH (2) OF THIS SUBSECTION, ANY student who attends a community college in this State and is not a resident of this State shall pay, in addition to the student tuition and fees payable by a county resident, an out-of-state fee, equal to the State share and the county share per full-time equivalent student as determined under § 16-403 of this subtitle.

~~(2) THE STATE SHARE OF THE OUT OF STATE FEE IS WAIVED FOR A STUDENT WHO RESIDES IN THE STATE OF WEST VIRGINIA AND ATTENDS GARRETT COMMUNITY COLLEGE, IF THE STATE OF WEST VIRGINIA AGREES TO WAIVE OUT OF STATE FEES FOR GARRETT COUNTY RESIDENTS WHO ATTEND INSTITUTIONS OF HIGHER EDUCATION IN THAT STATE. IN ADDITION TO THE STATE SHARE DETERMINED UNDER § 16-403 OF THIS SUBTITLE, THIS STATE SHALL PAY TO GARRETT COMMUNITY COLLEGE THE FEES WAIVED UNDER THIS PARAGRAPH, AS PROVIDED IN THE STATE BUDGET.~~

(2) A RESIDENT OF THE STATE OF WEST VIRGINIA WHO ATTENDS GARRETT COMMUNITY COLLEGE UNDER A NEGOTIATED RECIPROCCITY AGREEMENT BETWEEN THE STATES OF MARYLAND AND WEST VIRGINIA IS AN IN-COUNTY RESIDENT FOR TUITION PURPOSES AND SHALL BE COUNTED AS AN IN-STATE RESIDENT FOR COMPUTATION OF THE STATE AID TO COMMUNITY COLLEGES IN ACCORDANCE WITH SECTION 16-403 OF THIS SUBTITLE. THE STATE BOARD FOR COMMUNITY COLLEGES MAY MAKE PAYMENTS TO EFFECTUATE THE PROVISIONS OF THIS PARAGRAPH FROM FUNDS SPECIFICALLY APPROPRIATED FOR THIS PURPOSE AS PROVIDED IN THE STATE BUDGET OR ANY SUPPLEMENTAL BUDGET REQUEST.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 1978.

Juvenile Causes - Juvenile Code

FOR the purpose of clarifying and revising certain
