TEACHERS AND ANY OTHER PROFESSIONAL PERSONNEL AT THE MARYLAND SCHOOL FOR THE DEAF AND THE MARYLAND SCHOOL FOR THE BLIND SHALL BE PAID AN ANNUAL SALARY THAT IS AT LEAST EQUAL TO THE SALARY RECEIVED BY PUBLIC SCHOOL TEACHERS AND PROFESSIONAL PERSONNEL OF SIMILAR TRAINING AND EXPERIENCE IN THE COUNTY IN WHICH THE SCHOOL IS LOCATED.

8-309. PAYMENTS BY COUNTIES TO THE MARYLAND SCHOOL FOR THE BLIND.

(A) COUNTY TO PAY \$200 FOR EACH BLIND CHILD SENT.

EACH COUNTY SHALL PAY THE MARYLAND SCHOOL FOR THE BLIND \$200 A YEAR FOR EACH BLIND CHILD WHO IS SENT TO THE SCHOOL PROM THE COUNTY.

(B) CHARGE TO COUNTY: STATEMENT TO BE FURNISHED.

THE BOARD OF DIRECTORS OF THE MARYLAND SCHOOL FOR THE BLIND SHALL GIVE EACH COUNTY TREASURER AND THE COMPTROLLER OF BALTIMORE CITY ON APRIL 1 AND OCTOBER 1 OF EACH YEAR A STATEMENT THAT CONTAINS:

- (1) THE NUMBER OF BLIND CHILDREN WHO ARE ATTENDING FROM THE COUNTY: AND
- (2) THE NAME OF EACH BLIND CHILD FROM THE COUNTY AND CHARGED TO THE COUNTY.
  - (C) PAYMENTS TO BE MADE BY MAY 1 AND NOVEMBER 1.
- (1) THE COUNTY GOVERNING BODY COUNCIL, BOARD OF COUNTY COMMISSIONERS, OR MAYOR AND CITY COUNCIL OF BALTIMORE CITY SHALL PAY TO THE MARYLAND SCHOOL FOR THE BLIND ON OR BEFORE MAY 1 AND NOVEMBER 1 OF EACH YEAR \$100 FOR EACH CHILD WHO IS SENT TO THE SCHOOL FROM THE COUNTY CERTIFIED AS OF APRIL 1 AND OCTOBER 1 TO THE TREASURER OF THE COUNTY AND THE COMPTROLLER OF BALTIMORE CITY BY THE BOARD OF DIRECTORS OF THE MARYLAND SCHOOL FOR THE BLIND.
