certain requirements; providing for the handling of contested cases generally; prohibiting ex parte communications in contested cases except under certain circumstances and generally relating to ex parte communications; providing that the filing of a petition does not stay the agencies decision except under certain circumstances; eliminating certain reasons for which the court may reverse or modify the decision of an agency; clarifying the language; and generally relating to the Administrative Procedure Act.

For the purpose of this subtitle:

(a) "Agency" means any State board, commission, department or officer authorized by law to make rules or to adjudicate contested cases, INCLUDING ANY AGENCY GREATED BY CINEBAL LAWS, WHICH—CPERATES IN TWO OR MORE POLITICAL SUBDIVISIONS except those in the legislative or judicial branches, AND THE GCVERNOR, and except the [-Maryland Parole Commission, the Livision of Parole and Probation, the Workmen's Compensation Commission, the State Accident Fund, the State Insurance I commission, the State Accident Fund, the State Insurance I commission, the Maryland, the Public Service Commission, the Employment Security Board and the State Tax Commission. The Maryland Automobile Insurance Fund shall not be considered an "agency" within the meaning of this section as to any matter or action with regard to which the Insurance Commissioner has made an express, written finding or determination that compliance with the provisions of the Administrative Procedure Act and/or the State I couments Law by the Maryland Automobile Fund is
