IN THE FRACTICE OF OCCUPATIONAL THERAPY.

- (E) THIS SUBTITLE SHALL NOT BE CONSTRUED TO PREVENT AN INCIVIDUAL LICENSED AS A PHYSICAL THERAPIST OR PHYSICAL THERAPIST ASSISTANT FROM THE DESIGN, FABRICATION, AND USE OF SELINTS AND ADAPTIVE EQUIPMENT: DEVELOPMENTAL, PERCEFTUAL MOTOR AND SENSORY INTEGRATIVE ACTIVITIES: ACTIVITIES OF DALLY LIVING: AND CONSULTATION CONCERNING THE ALAPTATION OF ENVIRONMENTS FOR THE HANDICAPPED, WITHIN THE SCOPE OF THEIR PROFESSIONAL COMPETENCE, IF THEY DO NOT HOLD TERMSELVES OUT BY ANY TITLE OR DESCRIPTION OF SERVICES AS BEING ENGAGED IN THE PRACTICE OF OCCUPATIONAL THERAPY.
- 42) CRINGISTS (C) THIS SUBTITLE DOES NOT AFFECT THE PRACTICE, SERVICES, OR ACTIVITIES OF ORTHOTISTS AND PRESTHETISTS FROM FITTING, MANUFACTURING, AND APPLYING SPLINTS OR CTHER ORTHOTIC DEVICES, WHILE PRACTICING WITHIN THE STANDARDS AND ETHICS OF THEIR PROFESSION IF THEY DO NOT HOLD THEMSELVES OUT EY ANY TITLE OR DESCRIPTION OF SERVICES AS BEING ENGAGED IN THE PRACTICE OF OCCUPATIONAL THERAPY.

913. ECARD ESTABLISHED.

THERE IS A BOARD OF OCCUPATIONAL THERAPY PRACTICE IN THE DEFARIMENT OF HEALTH AND MENTAL HYGIENE.

914. MEMBERSHIP.

(A) COMPOSITION.

- (1) THE ECARD CONSISTS OF FIVE MEMBERS EACH APPOINTED BY THE GOVERNOR ON THE RECOMMENDATION OF THE SECRETARY OF HEALTH AND MENTAL HYGIENE FROM A LIST OF NOTINEES PRESENTED BY THE MARYLAND OCCUPATIONAL THERAPY ASSOCIATION
 - (2) OF THE FIVE BOARD MEMBERS:
- (I) THREE SHALL BE LICENSED OCCUPATIONAL THERAPISTS;
- (II) CNE SHALL BE A LICENSED CCCUPATIONAL THERAPY ASSISTANT; AND
- (III) CNE SHALL BE A PUELIC MEMBER WHO IS NOT AN CCCUPATIONAL THERAPIST CR CCCUPATIONAL THERAPY ASSISTANT.
- (3) THE SIGRETARY OF HEALTH AND MENTAL—HYGIENE SHALL MAKE HIS BEGGMENGATION FOR THE OCCUPATIONAL THERAPIST AND—OCCUPATIONAL—THERAPIST AND—OCCUPATIONAL—THERAPY—ASSISTANT MEMBERS FROM A LIST OF NAMES SUBMITTED—TO THE SECRETARY—BY—THE—ASSOCIATION——THE LIST—SHALL—CCATAIN—THE NUMBER—OF NAMES THAT—IS THREE TIMES THE NUMBER—OF VACANCIES.
