922. EXAMINATIONS.

RIGHT TO EXAMINATION. (A)

IF AN APPLICANT OTHERWISE QUALIFIES POR A LICENSE UNDER THIS SUPTITLE HE IS ENTITLED TO BE EXAMINED AS PROVIDED IN THIS SECTION.

APPLICATION FOR EXAMINATION. (B)

AN APPLICANT SHALL SUBMIT AN APPLICATION FOR EXAMINATION AND THE FEE ESTABLISHED BY THE ECARD AT LEAST 30 DAYS PRICE TO THE DATE OF THE EXAMINATION.

(C) TIME AND FLACE OF EXAMINATION.

THE ECARD SHALL ADMINISTER EXAMINATIONS OF APPLICANTS AT LEAST TWICE A YEAR AT THE TIMES AND PLACES THAT IT SETS.

NOTICE OF EXAMINATION. (D)

THE ECARD SHALL NOTIFY A QUALIFIED APPLICANT BY MAIL OF THE TIME AND FLACE OF EXAMINATION.

SUBJECT AND RETHOD OF EXAMINATION. (E)

THE ECARD SHALL AFFROVE THE SUBJECTS, SCOPE, FORMAT, STANDARDS FOR ACCEPTABLE PERFORMANCE FOR EXAMINATIONS ADMINISTERED UNDER THIS SUBTITLE. THE EXAMINATION SHALL TEST THE APPLICANT'S KNOWLEDGE OF THE BASIC AND CLINICAL SCIENCES RELATING TO OCCUPATIONAL THERAPY, OCCUPATIONAL THERAPY THEORY AND FRACTICE, PROFESSIONAL SKILLS, JUDGMENT IN THE UTILIZATION OF CCCUPATIONAL THERAPY TECHNIQUES AND METHODS AND ANY OTHER SUBJECTS THAT THE BOARD MAY FIND USEFUL TO DETERMINE THE APPLICANT'S FITNESS FOR LICENSURE.
