- (4) TWO MEMBERS FROM BALTIMORE CITY: ONE SELECTED BY THE MAYOR OF BALTIMORE CITY AND ONE SELECTED BY THE PALTIMORE CITY COUNCIL:
- (5) TWO MEMBERS FROM BALTIMORE COUNTY --ONE SELECTED BY THE CCUNTY EXECUTIVE OF BALTIMORE COUNTY AND ONE SELECTED BY THE EALTIMORE COUNTY COUNCIL; AND
- (6) TWO MEMBERS SELECTED BY THE BALTIMORE REGIONAL PLANNING COUNCIL.
- (C) OF THE SIX COUNTY AND CITY MEMBERS, THERE SHALL BE AT LEAST:
- (1) ONE MEMBER OF THE COUNTY OR CITY LEGISLATIVE BODY; AND
- (2) CNE MEMBER OF THE GENERAL ASSEMBLY OF MARYLAND.
- (D) THE COMMISSION MAY SHALL APPOINT AN ADVISORY COMMITTEE COMPOSED OF INTERESTED CITIZENS AND DETERMINE THE NUMBER, TERMS, AND QUALIFICATIONS OF ITS MEMBERS.

- (A) THE CHAIRMAN OF THE COMMISSION SHALL BE SELECTED FROM THE MEMBERS OF THE COUNTY AND CITY BY A MAJORITY VOTE OF THE ENTIRE COMMISSION.
- (B) (1) THE MEMBERS SHALL MEET AT THE CHAIRMAN'S REQUEST AT LEAST FOUR TIMES EVERY YEAR ANNUALLY OR ANY TIME AT THE REQUEST OF AT-LEAST TWO A CHORUM OF MEMBERS OF THE COUNTY OR CITY.
