- (A) EVERY PERSON WHO SOLICITS, CAUSES, INDUCES, OR KNOWINGLY PERMITS A PERSON UNDER 16 YEARS OF AGE TO ENGAGE AS A SUBJECT IN THE PERCURCTION OF OBSCENE MATTER IS SUBJECT TO THE PENALTY PROVIDED IN SUBSECTION (C).

Any subsequent conviction of a violation of this subtitle is punishable by a fine of not to exceed [five thousand dollars (\$5,000.00)] \$5,000 or ky imprisonment for not to exceed three years, or both UNLESS OTHERWISE PROVIDED.
