

PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1957 EDITION AND AMENDMENTS THERETO) TITLE "CORPORATION-MUNICIPAL"; TO AMEND THE CHARTER OF THE CITY OF HAVRE DE GRACE, MARYLAND, BY ADDING A NEW SECTION 268E TO THE CODE OF PUBLIC LOCAL LAWS OF HARFORD COUNTY (1965 EDITION AND AMENDMENTS THERETO), BEING ARTICLE 13 OF THE PUBLIC LOCAL LAWS OF MARYLAND, TITLE "HARFORD COUNTY", SUBTITLE "HAVRE DE GRACE", ENLARGING THE BOUNDARIES OF THE CITY OF HAVRE DE GRACE.

WHEREAS, the owners of more than 25% of the assessed valuation of real property located in the area to be annexed have requested annexation into the City of Havre de Grace; and,

WHEREAS, there are no resident voters in the area to be annexed.

A RESOLUTION BY THE MAYOR AND CITY COUNCIL OF HAVRE DE GRACE, MARYLAND, ADOPTED PURSUANT TO THE AUTHORITY OF ARTICLE XI-E OF THE CONSTITUTION OF MARYLAND AND THE PROVISIONS OF ARTICLE 23A OF THE ANNOTATED CODE OF MARYLAND (1973 REPLACEMENT VOLUME, AS AMENDED) TITLE "CORPORATION-MUNICIPAL"; TO AMEND THE CHARTER OF THE CITY OF HAVRE DE GRACE, MARYLAND BY AMENDING SECTIONS 294 AND 299 OF THE CODE OF PUBLIC LOCAL LAWS OF HARFORD COUNTY (1965 EDITION, AS AMENDED), BEING ARTICLE 13 OF THE CODE OF PUBLIC LOCAL LAWS OF MARYLAND, TITLE "HARFORD COUNTY", SUBTITLE "HAVRE DE GRACE": TO CHANGE THE DAY ON WHICH MUNICIPAL ELECTIONS ARE HELD FROM THE FIRST MONDAY IN MAY TO THE FIRST TUESDAY IN MAY.
