IN AN AMOUNT DETERMINED BY THE UNIVERSITY OF MARYLAND, CONDITIONED THAT HE WILL TEACH IN A PUBLIC INSTITUTION OF HIGHER EDUCATION IN THIS STATE, IF HE CAN FIND A POSITION, FOR AT LEAST 3 YEARS AFTER HE RECEIVES A DOCTOR OF PHILOSOPHY OR DOCTOR OF EDUCATION DEGREE; AND

- (4) MAY NOT HOLD ANY OTHER SCHOLARSHIP OR FELLOWSHIP.
  - (C) STATE RESIDENTS PREFERRED.

IF POSSIBLE, RESIDENTS OF THIS STATE SHALL RECEIVE PREFERENCE IN THE AWARD OF THESE FELLOWSHIPS.

(D) UNIVERSITY TO COOPERATE.

THE UNIVERSITY OF MARYLAND SHALL COOPERATE WITH THE ACCREDITED INSTITUTIONS OF HIGHER EDUCATION IN THIS STATE BY SPECIFYING EACH YEAR THE REQUIREMENTS OF THE GRADUATE SCHOOL, THE STANDARDS FOR DETERMINING ELIGIBILITY FOR FELLOWSHIPS, AND THE FIELDS OF GREATEST NEED FOR QUALIFIED PACULTY IN THE PUBLIC INSTITUTIONS OF HIGHER EDUCATION IN THIS STATE.

(E) DURATION AND AMOUNT OF AWARD.

## EACH FELLOWSHIP:

- (1) MAY NOT BE FOR MORE THAN \$2,500 A YEAR.
- (2) MAY BE HELD FOR 3 YEARS IF THE RECIPIENT:
- (I) CONTINUES TO BE A FULL-TIME STUDENT AT THE UNIVERSITY OF MARYLAND AND CARRIES AT LEAST 12 SEMESTER HOURS OF COURSES EACH SEMESTER:
- (II) IN THE JUDGMENT OF THE UNIVERSITY, IS MAKING SATISFACTORY PROGRESS TOWARDS A DEGREE; AND
- (III) MAINTAINS THE DEPARTMENT STANDARDS OF THE UNIVERSITY.
  - (F) NUMBER OF FELIOWSHIPS, SELECTION OF APPLICANTS.
- (1) EACH YEAR, THE FELLOWSHIP COMMITTEE OF THE UNIVERSITY SHALL CERTIFY NOT MORE THAN 12 FELLOWSHIPS TO QUALIFIED APPLICANTS.
  - (2) IF POSSIBLE:
- (I) THE FULL NUMBER OF PELLOWSHIPS SHALL BE AWARDED;
- (II) THE DISTRIBUTION SHALL BE MADE AS WIDE AS POSSIBLE TO GRADUATES OF ACCREDITED INSTITUTIONS OF HIGHER EDUCATION IN THIS STATE; AND
  - (III) CONSIDERATION SHALL BE GIVEN TO THE
