QUALIFICATIONS WITH RESPECT TO VOCATIONAL EDUCATION, BUT WHO ARE NOT INVOLVED IN THE ADMINISTRATION OF STATE OR COUNTY VOCATIONAL EDUCATION;

- (II) ARE VOCATIONAL EDUCATION TEACHERS PRESENTLY TEACHING IN COUNTY EDUCATION AGENCIES:
- (III) ARE SUPERINTENDENTS OR OTHER ADMINISTRATORS OF COUNTY EDUCATION AGENCIES;
 - (IV) ARE COUNTY SCHOOL BOARD MEMBERS:
- (V) ARE WOMEN WITH BACKGROUNDS AND EXPERIENCES IN EMPLOYMENT AND TRAINING PROGRAMS AND KNOW ABOUT THE SPECIAL EXPERIENCES AND PROBLEMS OF WOMEN, INCLUDING SEX DISCRIMINATION IN JOB TRAINING AND EMPLOYMENT AND SEX STEREOTYPING IN VOCATIONAL EDUCATION:
- (VI) ARE WOMEN MEMBERS OF MINORITY GROUPS, WHO KNOW ABOUT DISCRIMINATION IN JOB TRAINING AND EMPLOYMENT AGAINST MINORITY GROUP WOMEN;
- (VII) HAVE SPECIAL KNOWLEDGE, EXPERIENCE, OR QUALIFICATIONS IN THE SPECIAL EDUCATIONAL NEEDS OF THE PHYSICALLY OR MENTALLY HANDICAPPED;
 - (VIII) ARE MEMBERS OF THE GENERAL PUBLIC; AND
 - (IX) ARE VOCATIONAL EDUCATION STUDENTS.
 - (C) MEMBER MAY REPRESENT MORE THAN ONE CATEGORY.

A MEMBER MAY REPRESENT MORE THAN ONE OF THE CATEGORIES ENUMERATED IN SUBSECTION (B) OF THIS SECTION. HOWEVER, A MAJORITY OF ITS MEMBERS SHALL BE INDIVIDUALS WHO ARE NOT EDUCATORS OR ADMINISTRATORS IN THE FIELD OF EDUCATION.

- (D) TERM AND VACANCIES.
- (1) EACH MEMBER SERVES FOR A TERM OF 3 YEARS AND UNTIL A SUCCESSOR IS APPOINTED AND QUALIFIES. EXCEPT AS PROVIDED IN SUBSECTION (A) OF THIS SECTION, THESE TERMS ARE STAGGERED AS REQUIRED BY THE TERMS OF THOSE SERVING ON JULY 1, 1978.
- (2) A MEMBER APPOINTED TO FILL A VACANCY SERVES ONLY FOR THE REMAINDER OF THAT TERM.
 - (E) COMPENSATION.

EACH MEMBER OF THE COUNCIL:

- (1) SERVES WITHOUT COMPENSATION: AND
- (2) IS ENTITLED TO REIMEURSEMENT FOR EXPENSES IN ACCORDANCE WITH THE STANDARD STATE TRAVEL REGULATIONS.
