- (3) MAKE OTHER STUDIES AND FURNISH REPORTS ON VOCATIONAL-TECHNICAL EDUCATION IN THIS STATE:
 - (I) ON ITS CWN INITIATIVE: OR
- (II) IF REQUESTED BY THE GOVERNOR OR THE GENERAL ASSEMBLY.

THE STATE BOARD OF EDUCATION. THE STATE BOARD FOR HIGHER EDUCATION, THE STATE BOARD FOR COMMUNITY COLLEGES, THE DEPARTMENT OF HUMAN RESOURCES, THE DEPARTMENT OF ECONOMIC AND COMMUNITY DEVELOPMENT, THE BOARD OF REGENTS OF THE UNIVERSITY OF MARYLAND, THE BOARD OF TRUSTEES OF STATE UNIVERSITIES AND COLLEGES, THE STATE MANPOWER SERVICES COUNCIL, AND ALL OTHER APPROPRIATE STATE AGENCIES SHALL WITH THE STATE ADVISORY COUNCIL ON COOPERATE VOCATIONAL-TECHNICAL EDUCATION IN SUPPLYING ANY STUDIES REPORTS REQUESTED BY THE COUNCIL.
