a similar requirement in §123A(b) and in light of the general proposition that the criminal laws of a state do not apply to activities occurring entirely outside the state.

The reference in present Art. 77, §96 to Baltimore City is deleted as unnecessary in light of the definition of "county" in §1-101 of this article.

The reference in present Art. 77, §96 to the injunction being issued and enforced in accordance with "The Maryland Rules" is deleted as unnecessary.

The only other changes are in style.

For penalties for carrying a deadly weapon on school property, see Art. 27, §36A of the Code.

26-102. TRESPASS ON THE GROUNDS OF A PUBLIC INSTITUTION OF ELEMENTARY, SECONDARY, OR HIGHER EDUCATION.

(A) DENIAL OF ACCESS TO SCHOOL GROUNDS.

THE PRESIDENT, PRINCIPAL, OR GOVERNING BOARD OF ANY PUBLIC INSTITUTION OF ELEMENTARY, SECONDARY, OR HIGHER EDUCATION MAY DENY ACCESS TO THE BUILDINGS OR GROUNDS OF THE INSTITUTION TO ANY PERSON WHO IS NOT A BONA FIDE, CURRENTLY REGISTERED STUDENT, OR STAFF OR FACULTY MEMBER AT THE INSTITUTION, AND WHO DOES NOT HAVE LAWFUL BUSINESS TO PURSUE AT THE INSTITUTION OR WHO ACTS IN A MANNER THAT DISRUPTS OR DISTURBS THE NORMAL EDUCATIONAL FUNCTIONS OF THE INSTITUTION.

(B) STAFF MAY DEMAND IDENTIFICATION.

ADMINISTRATIVE PERSONNEL AND AUTHORIZED EMPLOYEES OF ANY PUBLIC INSTITUTION OF ELEMENTARY, SECONDARY, OR HIGHER EDUCATION MAY DEMAND IDENTIFICATION AND EVIDENCE OF QUALIFICATION FROM ANY PERSON WHO DESIRES TO USE OR ENTER THE PREMISES OF THE INSTITUTION.

(C) PENALTY.

A PERSON IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$1000, IMPRISONMENT NOT EXCEEDING 6 MONTHS, OR FOTH IF HE:

- (1) TRESPASSES ON THE GROUNDS OF ANY PUBLIC INSTITUTION OF ELEMENTARY, SECONDARY, OR HIGHER EDUCATION;
- (2) FAILS OR REFUSES TO LEAVE THE GROUNDS OF ANY OF THESE INSTITUTIONS AFTER BEING REQUESTED TO DO SO BY AN AUTHORIZED EMPLOYEE OF THE INSTITUTION;
- (3) WILLFULLY DAMAGES OR DEFACES ANY BUILDING, FURNISHING, STATUE, MONUMENT, MEMORIAL, TREE, SHRUB, GRASS,
