

COMMISSIONERS ARE AUTHORIZED TO LEVY ANNUALLY AN AMOUNT SUFFICIENT TO PAY SUCH ADDITIONAL BENEFITS.

(C) WHEN BENEFITS LESS THAN \$125 PER MONTH IN CAROLINE COUNTY. —ANY PUBLIC SCHOOL TEACHER OF CAROLINE COUNTY WHO RETIRED PRIOR TO JULY 1, 1956, AND WHO IS RECEIVING ANY RETIREMENT BENEFIT (EXCLUSIVE OF A DISABILITY RETIREMENT ALLOWANCE) UNDER THE PROVISIONS OF THIS SUBTITLE, WHEN SUCH BENEFITS IN THE AGGREGATE ARE LESS THAN \$125 PER MONTH, SHALL RECEIVE AN ADDITIONAL SUM NOT EXCEEDING \$50 PER MONTH UPON APPLICATION TO THE BOARD OF COUNTY COMMISSIONERS, AND THE COMMISSIONERS SHALL LEVY ANNUALLY AN AMOUNT SUFFICIENT TO PAY SUCH ADDITIONAL BENEFITS. THE SUM GRANTED TO ANY APPLICANT BY THE COUNTY COMMISSIONERS (SUBJECT TO THE \$50 LIMITATION) SHALL BE SUCH THAT WHEN ADDED TO WHATEVER THE APPLICANT IS RECEIVING FROM THE TEACHERS' RETIREMENT SYSTEM, THE TOTAL SHALL NOT EXCEED \$125 PER MONTH.

92. ADDITIONAL PAYMENTS WHEN RETIREMENT BENEFITS BELOW CERTAIN AMOUNTS—CHARLES COUNTY.

THE COUNTY COMMISSIONERS OF CHARLES COUNTY SHALL PAY TO ANY SCHOOL TEACHER OF CHARLES COUNTY WHO IS RETIRED FROM TEACHING SERVICE AND WHO IS RECEIVING ANY RETIREMENT BENEFITS UNDER THE PROVISIONS OF THE STATE TEACHERS' RETIREMENT SYSTEM OF THE STATE OF MARYLAND, WHERE SUCH BENEFITS IN THE AGGREGATE ARE LESS THAN \$115 PER MONTH, AN ADDITIONAL SUM NOT EXCEEDING \$25 PER MONTH UPON APPLICATION TO THE COUNTY COMMISSIONERS.

93. ADDITIONAL PAYMENTS WHEN RETIREMENT BENEFITS BELOW CERTAIN AMOUNTS—CAROLINE, TALBOT AND QUEEN ANNE'S COUNTIES.

ANY PUBLIC SCHOOL TEACHER OF CAROLINE COUNTY WHO IS RETIRED AND WHO IS RECEIVING ANY RETIREMENT BENEFITS UNDER THE PROVISIONS OF THIS SUBTITLE SHALL RECEIVE AN ADDITIONAL SUM AS SPECIFIED IN THIS SECTION. ANY SUCH TEACHER WHO IS RECEIVING LESS THAN \$50 PER MONTH FROM RETIREMENT PAYMENTS UNDER THIS SUBTITLE SHALL BE PAID AN ADDITIONAL \$20 PER MONTH BY THE COUNTY COMMISSIONERS OF CAROLINE COUNTY. ANY PUBLIC SCHOOL TEACHER WHO IS RECEIVING AN AMOUNT BETWEEN \$50 AND \$75 PER MONTH FROM RETIREMENT PAYMENTS UNDER THIS SUBTITLE SHALL RECEIVE AN ADDITIONAL PAYMENT OF \$15 PER MONTH. THE COUNTY COMMISSIONERS OF CAROLINE COUNTY ARE AUTHORIZED AND DIRECTED TO MAKE THE PAYMENTS AS PROVIDED IN THIS SECTION AND TO LEVY AGAINST THE TAXABLE PROPERTY FOR SUCH PURPOSE. IN TALBOT AND QUEEN ANNE'S COUNTIES THE ADDITIONAL PAYMENTS SHALL BE AS FOLLOWS: TEACHERS RECEIVING LESS THAN \$50 PER MONTH FROM RETIREMENT PAYMENTS SHALL RECEIVE AN ADDITIONAL \$25 UNDER THIS SECTION; ALL RECEIVING BETWEEN \$50 AND \$75 AN ADDITIONAL \$20.

94. ADDITIONAL PAYMENTS WHEN RETIREMENT BENEFITS BELOW CERTAIN AMOUNTS—WASHINGTON COUNTY.

THE COUNTY COMMISSIONERS OF WASHINGTON COUNTY SHALL HAVE THE POWER AND AUTHORITY, IN THEIR DISCRETION, TO PAY TO ANY SCHOOL TEACHER OF WASHINGTON COUNTY WHO IS RETIRED FROM
