holiday, the certificates must be received and filed not later than nine p.m. on the next regular business day which is not-a-legal holiday.

4A-4.--Vacancy in nomination by reason of there being no candidate to file How-filled.

(d) Exceptions.

The provisions of this section shall not apply to the filling of vacancies, as specified in § 9-2 of this article, nor TO VACANCIES FOR THE OFFICE OF COUNTY BOARD OF EDUCATION, NOR to special elections held to fill vacancies in office caused by death, resignation or otherwise, nor to political parties which are not required to nominate candidates by means of primary elections.

4A-6.-Fees-Filing fees-

(I) EXCEPT IN HOWARD COUNTY, EACH CANDIDATE FOR A COUNTY-BOARD OF EDUCATION SHALL PAY A FILING FEE OF \$25 AT THE TIME OF FILING HIS CERTIFICATE OF CANDIDACY AND PETITION. IN HOWARD COUNTY, THE FILING FEE IS \$10.

5-1. Parties-using.

Any-political party-with-which-ten-per-centum-or-more of the registered votors of this State are affiliated, as shown-by-the-most-recent statement-of-registration of the State Administrative -- Board of Bloction Laws - compiled pursuant to § 3-91 (b) of this article shall nominate (1) all-its-candidates for public-office; and (2) all members of the State and local contral committees in said political party-at-the-succeeding-primary election-conducted-under-the provisions of this subtitle; and shall elect the appropriate number of delegates to a national convention as provided in this article. CANDIDATES FOR A COUNTY BOARD OF EDUCATION SHALL-BE-NOMINATED AT A PRIMARY ELECTION WHEN SO PROVIDED IN THE EDUCATION ARTICLE. The several boards shall not print on the official ballot to be woted at any general or special election to be hereafter hold the name or names of any such candidate-or-candidates-for-election-in-Baltimore--City or any of the counties of the State of any of said parties who shall-not-be so-nominated-and-whose-nomination-shall-not-be certified to them or to the State Administrative Board of Election Laws as having been so nominated.

(C) -IN A COUNTY-THAT BEQUIRES A PRIMARY -ELECTION FOR COUNTY -BOARD -OF EDUCATION MEMBERS, CANDIDATES FOR A COUNTY BOARD -OF EDUCATION SHALL BE NOMINATED -ON THE APPROPRIATE PRIMARY -ELECTION -DATE -AS DETERMINED IN SUBSECTION (A) OF THIS SECTION IN EACH YEAR THAT -ONE -OR MORE -COUNTY BOARD OFFICES ARE TO BE FILLED AT THE GENERAL ELECTION.
