THE BOARD OF SUPERVISORS OF ELECTIONS SHALL PLACE ON THE BALLOT FOR THE GENERAL ELECTION ONLY THE NAMES OF THE REMAINING CANDIDATES.

(4) ANY PERSON SUBJECT TO THE AUTHORITY OF THE BOARD OF EDUCATION OF MONTGOMERY COUNTY MAY NOT BE CERTIFIED AS A CANDIDATE.

(B) ELECTION.

THE BOARD OF SUPERVISORS OF ELECTIONS OF MONTGOMERY
COUNTY SHALL PROVIDE FOR THE ELECTION OF MEMBERS OF THE
BOARD OF EDUCATION AS HEREIN PROVIDED. EXCEPT FOR ANY
ELECTION AT WHICH THE USE OF LECTRONICALLY TABULATED THE PUNCHCARD BALLOTS HAS BEEN AUTHORIZED BY STATE ADMINISTRATIVE BOARD OF ELECTION LAWS PURSUANT TO \$16A-1 OF THIS ARTICLE, PROVISIONS SHALL BE MADE FOR USE OF VOTING MACHINES, OR, IN THE ALTERNATIVE, FOR THE USE OF PAPER BALLOTS UNDER THE CONDITIONS HEREIN PRESCRIBED. THE NAMES OF ALL CANDIDATES WHO HAVE BEEN DULY NOMINATED UNDER THE PROVISIONS OF SUBSECTION (A) OF THIS SECTION FOR ELECTION TO THE SEVERAL BOARD OF EDUCATION OFFICES SHALL, EXCEPT IN THE CASE OF DEATH, BE PLACED ON THE BALLOT. THE FOUR PERSONS AMONG THE EIGHT IN THOSE YEARS WHEN ELECTIONS SHALL BE HELD FOR FOUR MEMBERS TO THE COUNTY BOARD OF EDUCATION AT LARGE AND THREE PERSONS AMONG THE SIX IN THOSE YEARS ELECTIONS SHALL BE HELD FOR THREE MEMBERS TO THE COUNTY BOARD OF EDUCATION AT LARGE, WHOSE NAMES ARE PLACED ON THE BALLOT AS CANDIDATES FOR ELECTION TO THE COUNTY BOARD OF EDUCATION AT LARGE WHO RECEIVE THE LARGEST NUMBER OF VOTES ELECTION, SHALL BE DECLARED ELECTED SAID FOR RESPECTIVE BOARD OF EDUCATION OFFICES. ALL VOTING FOR COUNTY BOARD OF EDUCATION MEMBERS, EITHER IN A PRIMARY ELECTION OR IN A GENERAL ELECTION, SHALL BE CONDUCTED ON A NONPARTISAN BASIS AND ON A GENERAL COUNTYWIDE TICKET; NO DESIGNATION OF PARTY AFFILIATION SHALL BE PLACED UPON ANY PETITION FOR NOMINATION, NOR UPON ANY VOTING MACHINE, PUNCHCARD BALLOT, OR PAPER BALLOT USED AT ANY SAID PRIMARY OR GENERAL ELECTION.

32-7. PRINCE GEORGE'S COUNTY.

(A) IN GENERAL.

ALL MEMBERS OF THE PRINCE GEORGE'S COUNTY BOARD SHALL BE NOMINATED AND ELECTED BY THE QUALIFIED VOTERS OF THEIR RESPECTIVE DISTRICTS. EACH MEMBER, AT THE TIME OF THEIR ELECTION, SHALL EACH RESIDE IN A DIFFERENT ONE OF THE NINE SCHOOL BOARD DISTRICTS OF THE COUNTY. ANY MEMBER WHO CEASES TO RESIDE IN THE SCHOOL BOARD DISTRICT FROM WHICH HE OR SHE WAS ELECTED SHALL CEASE TO BE A MEMBER OF THE BOARD. ALL VOTING FOR THE BOARD MEMBERS, EITHER IN A PRIMARY ELECTION OR IN A GENERAL ELECTION SHALL BE CONDUCTED ON A NONPARTISAN BASIS; NO DESIGNATION OF PARTY AFFILIATION SHALL BE PLACED UPON ANY PETITION FOR NOMINATION; NOR UPON ANY VOTING MACHINE OR PAPER BALLOT USED IN ANY PRIMARY OR GENERAL ELECTION.
