FOR NOMINATION TO THE BOARD OF EDUCATION, AND WHO REQUIRED, BY VIRTUE CF THE PROVISIONS OF THIS SECTION, TO RUN IN A PRIMARY ELECTION, MAY ON OR BEFORE 45 DAYS PRECEDING THE PRIMARY ELECTION, IN A WRITING SIGNED BY HIM AND ACKNOWLEDGED BEFORE AN OFFICER DULY AUTHORIZED TO TAKE ACKNOWLEDGMENTS UNDER THE LAWS OF MARYLAND, NOTIFY THE BOARD OF SUPERVISORS OF ELECTIONS OF PRINCE GEORGE'S COUNTY THAT HE OR SHE DESIRES TO WITHDRAW AS A CANDIDATE FOR FOR THE SPECIAL PRIMARY ELECTION A CANDIDATE NOMINATION. MAY WITHDRAW HIS CANDIDACY IN ACCORDANCE WITH THE PROVISIONS OF THIS SUBSECTION. IF THE WITHDRAWAL OF ANY CANDIDATE THE NOMINEES TO NOT MORE THAN TWICE THE NUMBER OF REDUCES MEMBERS TO BE ELECTED IC A PARTICULAR OFFICE ON THE BOARD, THE BOARD OF SUPERVISORS OF ELECTIONS SHALL CERTIFY SUCH REMAINING CANDIDATES AS PROVIDED BY PARAGRAPH (2) OF THIS SUBSECTION. NO PERSON SHALL BE CERTIFIED AS A CANDIDATE WHO IS EMPLOYED BY THE BOARD.

(C) ELECTIONS.

THE BOARD OF SUPERVISORS OF ELECTIONS OF PRINCE GEORGE'S COUNTY SHALL PROVIDE FOR THE ELECTION OF MEMBERS OF THE BOARD OF EDUCATION. PROVISIONS SHALL BE MADE FOR USE OF VOTING MACHINES, OR, IN THE ALTERNATIVE, FOR THE USE OF PAPER BALLCTS UNDER THE CONDITIONS PRESCRIBED IN PARAGRAPH THREE OF SUBSECTION (B) OF THIS SECTION. THE NAMES OF ALL CANDIDATES WHO HAVE BEEN DULY NOMINATED UNDER THE PROVISIONS OF SUBSECTION (B) OF THIS SECTION SHALL, EXCEPT IN THE CASE OF DEATH, BE PLACED ON THE BALLOT. THE BOARD OF SUPERVISORS OF ELECTIONS SHALL PROVIDE THE MEANS WHEREBY ALL REGISTERED VOTERS OF THE COUNTY, IRRESPECTIVE OF PARTY AFFILIATION, MAY VOTE FOR THE NOMINEES FOR THE BOARD IN THE PRIMARY ELECTION OF FOR THE CANDIDATE IN EACH DISTRICT, WHO RECEIVES THE LARGEST NUMBER OF VOTES IN THE GENERAL ELECTION SHALL BE DECLARED ELECTED FOR THE RESPECTIVE BOARD OF EDUCATION OFFICES.

(D) VACANCY IN CANDIDACY.

THE PRINCE GEORGE'S COUNTY EXECUTIVE SHALL APPOINT, SUBJECT TO CONFIRMATION BY THE COUNTY COUNCIL, A DULY QUALIFIED PERSON TO ASSUME THE CANDIDACY IF, AFTER THE PRIMARY ELECTION AND BEFORE THE GENERAL ELECTION, ONLY ONE CANDIDATE HAS BEEN CERTIFIED BY THE BOARD OF ELECTIONS AND THAT CANDIDATE IS UNABLE TO CONTINUE AS A CANDIDATE FOR ANY REASON.

(E) CAMPAIGN EXPENDITURES.

ALL CANDIDATES AND NOMINEES SHALL FILE INFORMATION RELATING TO THEIR CAMPAIGN EXPENDITURES IN ACCORDANCE WITH THE PROVISIONS OF THIS ARTICLE.

32-8. WASHINGTON CCUNTY.

(1) NOMINATION FOR MEMBERSHIP ON THE BOARD OF EDUCATION OF WASHINGTON COUNTY EXCEPT AS OTHERWISE HEREIN PROVIDED, SHALL BE BY PETITION ENDORSED BY A MINIMUM OF 300
