

SCHOOL BOARD DISTRICT III CONSISTS OF ALL OF ELECTION DISTRICT 17.

(E) DISTRICT IV.

SCHOOL BOARD DISTRICT IV CONSISTS OF PRECINCTS 1 AND 2 OF ELECTION DISTRICT 16, ALL OF ELECTION DISTRICT 2, AND PRECINCTS 1, 2, 3, 6, 7, AND 9 OF ELECTION DISTRICT 20.

(F) DISTRICT V.

SCHOOL BOARD DISTRICT V CONSISTS OF ALL OF ELECTION DISTRICTS 3, 7, 14, AND 15, PRECINCTS 4 AND 5 OF ELECTION DISTRICT 20, AND PRECINCT 4 OF ELECTION DISTRICT 13.

(G) DISTRICT VI.

SCHOOL BOARD DISTRICT VI CONSISTS OF PRECINCTS 1, 2, 3, AND 5 OF ELECTION DISTRICT 13, ALL OF ELECTION DISTRICT 18, AND PRECINCT 8 OF ELECTION DISTRICT 20.

(H) DISTRICT VII.

SCHOOL BOARD DISTRICT VII CONSISTS OF PRECINCTS 1, 3, 4, 5, 6, 10, 11, 12, 15, 16, AND 17 OF ELECTION DISTRICT 6.

(I) DISTRICT VIII.

SCHOOL BOARD DISTRICT VIII CONSISTS OF PRECINCTS 8, 9, AND 14 OF ELECTION DISTRICT 6 AND ALL OF ELECTION DISTRICT 12.

(J) DISTRICT IX.

SCHOOL BOARD DISTRICT IX CONSISTS OF ALL OF ELECTION DISTRICTS 4, 5, 8, 9, AND 11 AND PRECINCTS 2, 7, 13, AND 18 OF ELECTION DISTRICT 6.

(K) REDISTRICTING.

(1) BEGINNING IN 1981, THERE SHALL BE A REDISTRICTING EVERY 10 YEARS BASED ON THE LATEST U.S. CENSUS DATA.

(2) THE SCHOOL BOARD DISTRICTS SHALL BE DIVIDED INTO THREE GROUPS:

(I) GROUP I CONSISTS OF SCHOOL BOARD DISTRICTS ~~1, 4, AND 7~~ I, IV, AND VII;

(II) GROUP II CONSISTS OF SCHOOL BOARD DISTRICTS ~~2, 5, AND 8~~ II, V, AND VIII; AND

(III) GROUP III CONSISTS OF SCHOOL BOARD DISTRICTS ~~3, 6, AND 9~~ III, VI, AND IX.
