- (A-2) (1) NOTWITHSTANDING ANY OTHER PROVISION OF THIS SECTION, IN MONTGOMERY COUNTY THE HOLDER OF A CLASS B (ON-SALE HOTELS AND RESTAURANTS) BEER, WINE AND LIQUOR LICENSE UNDER THIS ARTICLE, BY MAKING APPLICATION IN THE REGULAR MANNER AND PAYING THE USUAL FEE, MAY OBTAIN THE ADDITIONAL CLASS B (ON-SALE HOTELS AND RESTAURANTS) BEER, WINE AND LIQUOR LICENSES AUTHORIZED BY THIS SUBSECTION.
- A LICENSE HOLDER WHOSE PRINCIPAL PLACE OF BUSINESS IS LOCATED IN THE STATE OF MARYLAND AND WHO HAS BEEN A CLASS B LICENSE HOLDER IN MONTGOMERY COUNTY FOR A MINIMUM OF 3 YEARS, MAY OBTAIN ONE ADDITIONAL CLASS B (ON-SALE - HOTELS AND RESTAURANTS) BEER, WINE AND LIQUOR LICENSE FOR PREMISES USED AND OCCUPIED AS A BONA FIDE RESTAURANT, AS DEFINED BY THE RULES AND REGULATIONS OF THE BOARD OF LIQUOR LICENSE COMMISSIONERS FOR MONTGOMERY COUNTY. THE RESTAURANT SHALL HAVE A CAPITAL INVESTMENT OF NOT LESS
 THAN \$250,000 FOR RESTAURANT FACILITIES, WHICH SUM MAY NOT
 INCLUDE THE COST OF LAND OR BUILDINGS, AND SHALL HAVE A
